# PRESBYTERY OF WESTERN NORTH CAROLINA COMMISSION ON MINISTRY/PREPARATION FOR MINISTRY TEAM BACKGROUND CHECK POLICY

- 1. The General Presbyter, Associate Presbyter, Stated Clerk, or Presbytery staff acting on their instructions, shall obtain a background check on each minister coming into the Presbytery, any candidate to be a Commissioned Pastor, candidates who are ready for ordination to the Ministry of Word and Sacrament, and any person seeking to be enrolled as an inquirer or candidate for the ministry.
- 2. Items included in the background check shall be:
  - locations lived
  - criminal records\*
  - motor vehicle records\*
  - sex offender registry
  - credit reports
  - other relevant records (\*inapplicable states)
- 3. Both COM and PMT shall use the same agency.
- 4. Requests for background checks will be initiated only with the consent of the minister, candidate for ministry, CLS student or person seeking to become an inquirer or candidate, who will assist by providing their date of birth, social security number, and other relevant information.
- 5. Information obtained from the background checks will be promptly shared with the minister, CLS student, candidate for ministry, or the person seeking to become an inquirer or candidate concerned (who will be afforded the opportunity to offer any explanatory supplement) and with the COM or PMT chair, who will decide whether any item therein needs to be shared with the whole team.
- 6. The background check reports shall be placed in the minister's, CP candidate's or inquirer/candidate's file and may be accessed by only the General Presbyter, an Associate Presbyter, the Stated Clerk or the COM or CPM chair, or Presbytery staff acting on their instructions. These reports shall not be disseminated without the knowledge of the minister/CLS student/candidate for ordination to ministry/inquirers/candidates concerned.

Adopted by the Committee on Ministry (now called Commission on Ministry) on December 13, 2005 and the Committee on Preparation for Ministry (now called Preparation for Ministry Team) on January 18, 2006.
