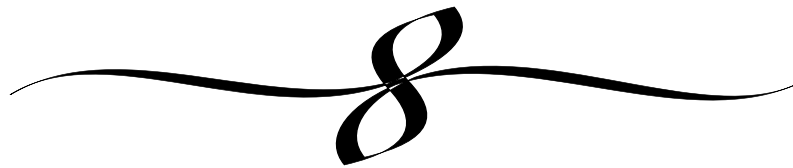
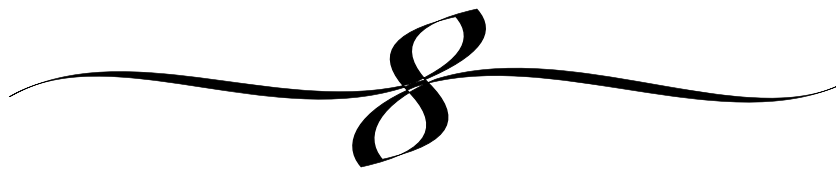

**CONSTITUTION**

7. The substitute motion is a form of amendment applied when the desire is to amend a motion in several different, nonconsecutive places. It also is used when the text to be amended is longer than a paragraph.

The following procedure is used after a substitute motion is made.

1. The Moderator calls for perfecting amendments to the main motion. The amendments may be debated. Nothing else is in order.

2. The Moderator calls for perfecting amendments to the substitute motion. The amendments may be debated. Nothing else is in order.

3. The Moderator puts the question: "Shall the substitute motion be substituted for the main motion?" At this time, the merits of the main motion and the substitute motion may be debated, but no further amendments are in order.

4. The Moderator takes vote on the question. (See #3.)

a. If the question is approved, the main motion disappears and the substitute motion is before the assembly for debate and vote. Substantive amendment is out of order. Editorial amendment is in order.

b. If the question is defeated, the substitute motion disappears and the main motion is before the assembly for debate and vote. The main motion may continue to be amended.

**11. THAT the Presbytery of Western North Carolina give approval to the Union Presbyterian Church in Gastonia to borrow up to \$450,000 from the General Assembly on a 15-year mortgage. Currently, the Union Presbyterian Church does not have any outstanding liens or mortgages against the property. **SERVICE OF WORSHIP, INCLUDING INSTALLATION OF GENERAL PRESBYTER  
AND CELEBRATION OF THE LORD'S SUPPER**

The Rev. Dr. David Hosick, Tryon Presbyterian Church, the Rev. Kathy Campbell, Chaplain at Lees-McRae College and Mr. Jim Taylor, Lees-McRae College, led the service of worship, which included the installation of General Presbyter, the Rev. Barbara "Bobbi" White, and a celebration of the Lord's Supper.

Mr. Taylor provided a collection of preservice music which included some of the following hymns: “*How Great Thou Art*,” “*He Knows My Name*,” and “*Come Thou Fount*.” For the call to worship, Mr. Taylor sang, “*Down to the Valley to Pray*.”

Dr. Hosick’s sermon, “*Keeping Our Covenant*,” came from the scripture Hosea 1:1-11. Dr. Hosick reminded the congregation that those who accept a call to ordination in the PC(USA) as a minister, elder or deacon take vows, and in doing so, they make a covenant with God and the church. The vows they take contain no contingencies, and honoring them, in season and out of season, is essential to fulfilling their call. Following Dr. Hosick’s sermon, the Rev. Bobbi White was installed as the new General Presbyter for the Presbytery of Western North Carolina. She answered affirmatively the Constitutional Questions from the *Book of Order*, G-14.0405.

The Rev. Kathy Campbell led the congregation in the celebration of the sacrament of the Lord’s Supper, which included a video entitled, “*Coming Home to Dinner*.”

### MISSIONS COMMITTEE

Kevin Frederick, Chair of Missions Committee, asked “*Got Mission?*” “*Got Mission*” is a campaign to have every congregation in Presbytery directly linked in support of at least one PC(USA) missionary by the end of the year 2007. He encouraged each congregation to actively support at least one PC(USA) missionary. Currently, there are 49 congregations within the Presbytery supporting, or having agreed to support, a PC(USA) missionary.

The Rev. Ellen Dozier, Missionary in Guatemala, commissioned the Rev. Dr. Rebecca (Becca) Young. She has been called as Professor of Systematic Theological Seminary in Jakarta, Indonesia. Members of the Arbor Dale and Reems Creek-Beech churches, as well as, others were asked to join Becca in her commissioning. Ellen Dozier charged Becca to remember to whom she belongs; to remember who she is; and to remember her task.

Mission teams going to Guatemala, Malawi and Mexico were introduced by the Rev. Ellen Dozier. She asked all members to go forward as ambassadors, to go with the love and the power of God, and that the blessings of God’s Holy Spirit will sustain them and give them guidance and hope.

#### **Rev. Dozier then charged all three mission teams:**

- to look behind and underneath the smiles of children;
- to look behind the scenery;
- to see the piles of garbage;
- to see, hear and listen to the violence in these countries;
- to be blessed by the families who invite you to their homes;
- to be blessed by the families and companions of those who travel with you;
- to be blessed by the faithfulness of those around you;
- to be blessed by your spirit that will move along you like the wind;

#### **Rev. Dozier then charged the Presbytery:**

- to enfold these brothers and sisters in your arms;
- to pray for their travel, their families, and their churches;
- to pray that they might have open minds and hearts;
- to pray that the families they visit will welcome them with open arms;
- to continue to pray for Becca after these teams have returned home;
- to listen to the stories of how God has been working in their lives when they return home.



The Rev. Kevin Frederick offered prayer following the commissioning of Becca and the three mission teams. The commissioning service was closed with everyone singing “Amazing Grace.”

### HUNGER COMMITTEE

Dennis Stamper, on behalf of the Hunger Committee, reported that Souper Bowl Sunday had been a great success, with youth from 62 of our churches participating. They collected a total of \$24,068.80 and 5,279 food items, plus \$13,363.40 in subsidy from the Nickel a Meal Program for a grand total of \$37,431.79. The Presbytery of Western North Carolina collected 13% of all money collected in North Carolina. The money collected on Souper Bowl Sunday goes to support local missions.

### CHRISTIAN EDUCATION

Kathy Parse, Chair of Christian Education Committee, recognized and commissioned Christian Educators Betty Davenport and Ginny Soll as POINT Trainees for the Presbytery. Kathy emphasized that Betty and Ginny had received extensive training in the new curriculum and encouraged the churches to utilize their training.

Betty Davenport, Chair of the Division of Educational Ministries and of the Let’s Celebrate Task Force, encouraged everyone to attend the leadership training event for adults and youth that is to be held on Saturday, August 18, 2007 at the First Presbyterian Church in Morganton.

### COMMITTEE ON PREPARATION FOR MINISTRY

The Rev. Michael Poulos, co-moderator of the Committee on Preparation for Ministry, recommended the following, after the required examinations of Presbytery.

#### RECOMMENDATIONS:

<b>OM</b>	<b>I.</b> THAT Donald Andrew Beers, an inquirer from Burnsville First Presbyterian Church, be removed from the preparation for ministry process, per his request.
	<b>II.</b> THAT Leila E. Evans, having completed alternate means of satisfying the Committee on Preparation for Ministry of her competence in Theology, be declared ready to be examined for ordination, pending a call. (3/4 vote of Presbytery is required.)
	<b>III.</b> THAT Erin Michelle Keys, a member of the Asheville First Presbyterian Church, and a student at Columbia Theological Seminary, be enrolled as a candidate following the required examination of Presbytery.

Recommendation I had previously been approved in the Omnibus Motion. Recommendation II was approved by the required three-fourths majority.

After candidate Erin Michelle Keys shared her faith journey and her call to the ministry, Moderator Lauterer opened the floor for questions. There being no further questions for the candidate, the Presbytery approved, the enrollment of Erin Michelle Keys as a candidate. The Moderator then asked the questions in the Book of Order, G-14.0305f, which were answered in the affirmative. The Rev. Lynn Michie charged Ms. Keys and the Rev. Michael Poulos offered prayer. Those who had come in support of Ms. Keys were invited to come forward and share in the prayers.

**The Committee on Preparation for Ministry reports the following to the Presbytery of Western North Carolina for information:**

- Merriam A. Bass, a member of the Asheville First Presbyterian Church, was enrolled as an inquirer on March 21, 2007. Merri will be attending Union Theological Seminary in Charlotte.
- Leila E. Evans, a candidate from the West Avenue Presbyterian Church, was approved ready to receive a call on March 21, 2007.
- Nathan Wright, a candidate and member of the Montreat Presbyterian Church, was given permission to circulate his Personal Information Form.

**COORDINATING COUNCIL**

On behalf of the Rev. Jim Cockerham, Elder Bill Kantonen, Vice-Moderator of Presbytery, reported for the Coordinating Council and made the following recommendations. Bill Kantonen stated that recommendation #3 had previously been removed and that recommendation #6 had been previously approved. He then asked for a motion that the remaining recommendations be acted upon one at a time. Motion was made and approved.

- F.**    There will be written ballots for each of the two main motions (dismissal & property). Other voting will, at the discretion of the Moderator, be either by voice or by standing (with counting as necessary).

*(3 vacancies, 1 for the class of 2009, and 2 for the class of 2007. In order to balance clergy and lay representation, the committee needs 3 ministers, and representation from clusters A, B, & D.)*

In doing so, we confirm that she is a member of a church within our Presbytery and possesses the moral character, personal integrity, and fidelity to Presbyterian beliefs to serve on the Board of Trustees of Davidson College.**

- 7.**    **THAT an invitation from the Session of Third Street Presbyterian Church in Gastonia to host the July 29, 2008 meeting of Presbytery has been accepted.**
- 8.**    **THAT Massanetta Springs was granted permission to ask churches in our Presbytery for contributions to their capital campaign.**
- 9.**    **THAT a copy of the “Standards of Ethical Conduct of PCUSA,” along with a cover letter, be sent to all congregations recommending voluntary use.**
- 10.**    **THAT the Hunger Committee was granted permission to sell and take orders for Nickel a Meal T-shirts at the April 24, 2007 meeting of Presbytery.**
- 11.**    **THAT the Hunger Committee reported a total of 62 churches participated in the Nickel a Meal Souper Bowl Program. The Rev. Bobbi White, General Presbyter, relinquished her time on the docket and referred those in attendance to her written report, "Reflections from your General Presbyter." (Appendix E)

### **COMMITTEE ON MINISTRY INTRODUCTION OF NEW MEMBERS**

On behalf of the Examinations Committee and the Committee on Ministry, the Rev. Dr. Luke Harkey, co-moderator of the Examinations Committee, introduced the following new ministers in Presbytery, each of whom will be re-introduced and answer questions and sign the Book of Obligations at the July 31, 2007 meeting of Presbytery at Southminster Presbyterian Church. ### **COMMITTEE ON MINISTRY**

The Rev. Dr. Don Scofield, Chair of the Committee on Ministry, reported on actions taken by the Committee on Ministry on behalf of the Presbytery. (Appendix F) Recommendations II.A.2, II.B.2, XV.A.2 and XV.A.3 were earlier approved in the Omnibus Motion. (Appendix A) He recognized Pastors Don C. Richter, Ford F. G'Segner, Martin Concepcion, and Kathryn Dudley, all of whom are moving to new presbyteries, thanking them for their ministries in our Presbytery and praying God's blessing on them in their future service in the church.

### **NOMINATING COMMITTEE**

Elder Dick Graham, Chair of the Nominating Committee, presented the recommendations for committee vacancies and then moved approval of the Nominating Committee Report. (Appendix G) All were duly elected.

Elder Graham then moved to delay the election of commissioner representatives to the 2008 General Assembly until the July 31, 2007 meeting of Presbytery, stating that the Nominating Committee would like to present recommendations for all commissioner vacancies at one time. Motion was approved. (Appendix G)

### **COMMITTEE ON MINISTRY MONTREAT'S REQUEST FOR DISMISSAL - PART I**

The Rev. Dr. Don Scofield, Chair of the Committee on Ministry, in response to a request from the Montreat Presbyterian Church to be dismissed to the Evangelical Presbyterian Church, presented the revised recommended decision of the Special Task Force appointed by the Committee on Ministry. (Appendix H) Both the Coordinating Council and the Committee on Ministry endorsed the recommendation which was presented in two parts. Rev. Scofield then introduced the Rev. Richard

White, Associate Pastor of the Montreat Presbyterian Church and Elders Adam Boyd and Linda McCartney to present their arguments on behalf of the Montreat Presbyterian Church.

Following a lengthy discussion, Part I of the revised recommended decision to divide the current Montreat Presbyterian Church into two congregations was voted on by ballot. (Appendix H) The recommendation was approved by the required two-thirds vote. (Approve - 185; Disapprove - 69; Total Ballots Counted - 254)

### **COMMITTEE ON MINISTRY (Continued)**

The Rev. Dr. Don Scofield introduced Tony Baker, Pastor-elect at First Presbyterian Church Dallas, coming to the Presbytery of Western North Carolina as a candidate from the Presbytery of Charlotte. Mr. Baker then preached a sermon and answered questions from presbyters. The Rev. Dr. Luke Harkey moved, on behalf of the Committee on Ministry, that his sermon be approved and that he be ordained by the Presbytery of Western North Carolina. The motion passed and Dr. Harkey offered prayer and presented him with a Guatemalan stole.

### **COMMITTEE ON MINISTRY MONTREAT'S REQUEST FOR DISMISSAL - PART II (Property)**

Moderator Lauterer asked the Presbytery to consider a motion to reduce the previously approved time allocated for Phase II of Montreat's Request for Dismissal, reducing the total time to 45 minutes instead of 75 minutes. A motion for the 45 minutes was made, giving five minutes to the Committee on Ministry, five minutes to the Montreat Presbyterian Church, ten minutes for general discussion and twenty minutes for further decision. The motion was approved.

Elder Adam Boyd, Montreat Presbyterian Church, asked that the minutes reflect that the Montreat Presbyterian Church was not in agreement with the approved motion.

Dr. Scofield spoke on behalf of the Committee on Ministry and the Special Task Force regarding the church property, outlining the recommendation of the task force. (Appendix H)

After hearing from Pastor Richard White and other presbyters, Part II of the revised recommended decision regarding the property was voted on by written ballot. The recommendation was approved with 174 for approval, 35 for disapproval, for a total of 209 ballots. There was 1 faulty ballot and 1 abstaining ballot.

### **RECOGNITION OF DISSENT**

The Rev. Parker Williamson asked for recognition of those members of Presbytery who were in dissent of the decisions regarding the Montreat Presbyterian Church. The following members were in dissent of both Parts I and II of the recommended decision:

The Presbytery moved to approve the adoption of the resolution.

**WHEREAS**, we owe a debt of deep gratitude for the inspired, devoted, visionary and efficient leadership of Moderator Maggie Lauterer for her guidance during this very difficult but important meeting of Presbytery; and

**WHEREAS**, the Presbytery staff and the committee leadership have sought to help us conduct our business in an effective way guided by the spirit of our Lord; and
