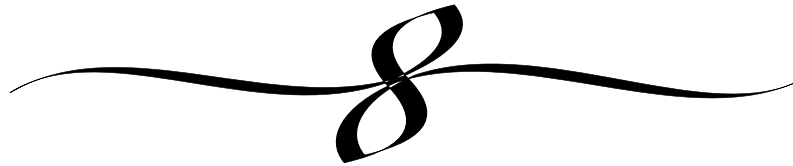

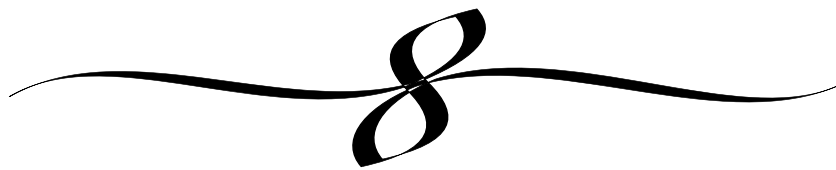

REPORT OF THE GENERAL PRESBYTER - Part I

**SERVICE OF WORSHIP
AND CELEBRATION OF THE LORD’S SUPPER**

Worship was led by the Rev. Pete Peery, President of the Montreat Conference Center; Dr. Stephen Hayner, President of Columbia Seminary; Rev. Susan Denne, Stated Supply Montreat Presbyterian Church; and Shannon Kershner, Pastor Black Mountain Presbyterian Church, with music led by Mike Barker of the Black Mountain Presbyterian Church. The Presbytery heard a sermon by Dr. Stephen Hayner, “More Joy in Heaven,” with the scripture taken from Luke 15:1-2; 7-10.

The Presbytery approved the recommendation that the Nominating Committee, along with the Moderator of Presbytery and the chair of the Committee on Ministry, be given the authority to replace a commissioner to the General Assembly in the event that the elected commissioner(s) and/or alternate commissioner(s) be unable to attend. The Rev. Luke Harkey offered prayers for the endorsement of the Rev. Maggie Lauterer to stand as candidate for the Moderator of the General Assembly.

YOUTH MISSION

On behalf of the Youth Committee, Chandler Guess and Adam Bowling presented a most interesting skit promoting the Senior High Youth Mission Retreat.

Beth Gunn promoted the PWNC Youth Council and encouraged the churches to pick up applications and have their youth complete and returns forms to her.

BUDGET & FINANCE COMMITTEE

Elder Charles Sellars, Chair of the Budget and Finance Committee, reported on the current state of the Presbytery’s finances and reported that a preliminary summary of the annual audit has been received with a copy of the final report to be included in the July Presbytery Packet. THAT the Presbytery NOT CONCUR with the Overture on Divestment from Caterpillar, Inc. to the 219th General Assembly of the Presbyterian Church (USA) by the Presbytery of Newark to divest funds from Caterpillar, Inc. because we see the MRTI Report to General Assembly as sufficient response to denounce the action of Caterpillar and with hope to continue the conversation by remaining as a stockholder and working with a new CEO arriving this summer. The Presbytery concurred with the recommendation of the Bills and Overture Committee by a vote of 68 to 57.
