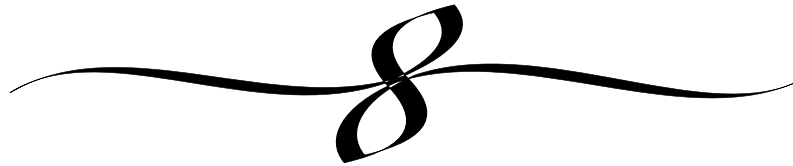

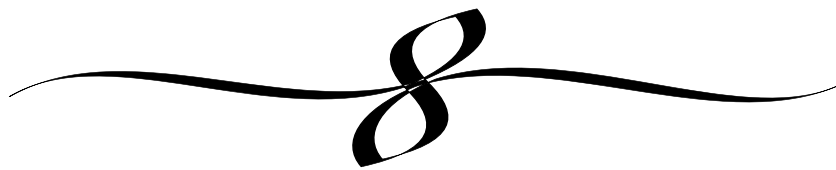

**SERVICE OF WORSHIP

MISSIONARY REPORT - BECCA YOUNG

Mission Co-Worker, Becca Young, reported on her work in Indonesia, describing the location as a series of islands stretching the distance from the California coast to the east coast of the USA. Indonesia is still recovering from the tsunami. After the recent tsunami, Christians and Muslims have been getting together to work on problems. Disaster work takes 25% of her time, and 75% is spent as a professor at Jakarta Seminary where her students learn to think practically, as well as theologically. She encouraged all to “spread the good news.”

The option to purchase must be exercised prior to July 30, 2012, or all rights to purchase expire. The option payments are non-refundable and immediately available to Presbytery for its use upon receipt, but will apply as full credits against the purchase price, if and when the option is exercised.**
- 2. If and when the option is exercised and the property is purchased, The Pisgah Center, Inc. will pay Presbytery of Western North Carolina as follows:**
 - a. Purchase price will be \$3,000,000.**
 - b. \$1,500,000 will be paid in cash at closing (minus the option payments).**
 - c. \$1,500,000 will be owner-financed as follows:**
 - (1) payable on or before the expiration of 5 years from the date of purchase,**
 - (2) interest payable at least annually at the rate of 3% per annum,**
 - (3) secured by a first lien deed of trust on the property, and**
 - (4) The Pisgah Center, Inc. will have a right of prepayment without penalty.**
- 3. The option will contain various additional standard terms, drafted and/or approved in form by an attorney for the Presbytery. During the option period, Presbytery will continue its lease arrangement with the State of North Carolina.**
- 4. The option and all such other documents as may now or hereafter be necessary or appropriate to consummate the option and any resulting sale of the property will be signed the Moderator and Stated Clerk on behalf of Presbytery, and by the Moderator of the Coordinating Council on its behalf as Trustees for the Presbytery.**

BACKGROUND - ADDITIONAL INFORMATION:

(Proposal for Option to Purchase Presbytery Property (250 acres +/-)Camp Little Pisgah (formerly) / Camp Woodson (currently)

The Pisgah Center, Inc., a tax-exempt nonprofit corporation, has requested an option to purchase the Presbytery's property in Buncombe County which formerly served as the Presbytery camp for Asheville Presbytery. Currently, the property is leased to the State of North Carolina as a wilderness and intensive support program for "at-risk" juvenile offenders. Lease payments approximately offset maintenance costs.

In 2007, the Coordinating Council, seeking to be faithful stewards of this financial, environmental and mission resource, ordered an appraisal and began discussions about future use of the property. In 2009, a group of conservation-minded Presbyterians and Presbyterians concerned about continuing a successful program for at risk kids and juvenile offenders sought and received assurances from the Coordinating Council that the property would not be sold before the end of 2010. In the meantime, values for large acreage tracts have deteriorated significantly, and future values are greatly at risk, due to both national economic and local governmental land use impacts. The Presbytery's appraiser currently has updated his appraisal to \$3,564,000, a surprisingly small decrease of approximately 18%.

On October 11, 2010, after the Presbytery packet had been distributed but prior to the Coordinating Council meeting, the Presbytery received the terms by which The Pisgah Center, Inc. desired to obtain an Option to purchase the property. Those terms could not be formulated until the appraisal had been completed, but will require action at this October Presbytery meeting in order for The Pisgah Center, Inc. to apply for major funding by an end of October deadline.)

Kevin Garvey of the Board of Pensions will be the leader.

CHRISTIAN EDUCATION COMMITTEE - ADAM BOWLING

Adam Bowling, chair of the Christian Education Committee, reported that their work continues, making resources available to local educators. A retreat for "teens and young adults," is planned for April 9, 2011 with Mary Todd Peters as keynoter. David LaMotte will present a musical program for this event. The educators retreat will be held at the First Presbyterian Church in Asheville. Mary Lou Nash was recognized as Certification Advisor for this Presbytery. She will be assisting those going through the certification process to become a Certified Christian Educator.

CAMPUS MISSION

Joseph Washburn, Campus Mission Committee and pastor of a church on Lees-McRae college campus, acknowledged the challenge of attracting college students into God's house. He referred to a handout included in the presbytery packet that suggested ways that local churches can relate to students: through "adoption," to be a student's home-away-from-home; inviting students to a covered-dish supper once a month at the church; and, inviting students to participate in mission projects. College students need to know that they are welcome in a church away from home.

PEACE AND JUSTICE

Lynn Michie, chair of the Peace and Justice Committee, reported that the committee is using peacemaking offering money to make small grants of at least \$250 to churches that are working in concrete ways toward

peacemaking in the community or the world. The deadline for these grant request forms is December 31, 2010.

PRAYERS OF INTERCESSION

The Rev. Becca Young led the Presbytery in prayers of intercession. The Presbytery recessed for lunch at 11:55 a.m.

Vice-Moderator, Dr. James Aydelotte reconvened the Presbytery at 1:30 p.m. with an opportunity for Presbyterians to address the Presbytery with announcements, concerns, and opinions.

The Presbyterian Home for Children in Black Mountain would like to encourage all churches within our Presbytery to have a liaison for the home. The home currently serves children and young adults from kindergarten through college students.

GRANDFATHER HOME FOR CHILDREN

On behalf of Grandfather Home for Children, Mae Weed brought greetings from the home and gave a brief history of the home and their needs. Grandfather Home for Children is now receiving children with special needs and children from mental health facilities. They have an established facility for these children that is separate from the other buildings. Foster care continues to be strictly monitored. Grandfather Home for Children is now electronically sending out a newsletter monthly. The new Campbell Cottage will open by the end of 2010.

WORK OF THE PRESBYTERY - BOBBI WHITE

REPORT OF THE GENERAL PRESBYTER

General Presbyter Bobbi White encouraged everyone to join God in God's work in the 112 churches in PWNC. She shared that we had 43 large, medium and small churches that grew in membership and worship attendance in 2009. We can become one of the presbyteries that are growing as we reach out to make disciples. Bobbi spoke of her visits with churches throughout the presbytery. She suggested we pray for God's guidance, try new things, risk failure and learn from it, and be flexible. She also reported the ways the Presbytery is helping churches through the Presbytery to grow and do mission.
