**145th STATED MEETING
PRESBYTERY OF WESTERN NORTH CAROLINA
January 31, 2026**

CALL TO ORDER

Teaching Elder Ken Murchison, Moderator, convened the 145th Stated Meeting of the Presbytery of Western North Carolina at 9:00 a.m. with prayer.

INSTALLATION OF MODERATOR, VICE-MODERATOR, AND STATED CLERK

As the immediate past Moderator, Teaching Elder Ken Murchison led a service to install Teaching Elder Wanda Neely as Moderator and Ruling Elder Robin Honeycutt as Vice-Moderator for 2026.

PRAYER OF INVOCATION

With the meeting of the 145th Stated Meeting of the Presbytery of Western North Carolina having been duly convened, Moderator Wanda Neely opened the meeting with the prayer of invocation.

LAND ACKNOWLEDGEMENT

The Coordinating Ministry has directed that we begin each Presbytery meeting with a land acknowledgment. Although various groups of indigenous peoples have populated the land that now forms our Presbytery, the Cherokees were the principal inhabitants at the time Europeans first arrived in Western North Carolina. Between 1830 and 1850, the United States military forced Cherokees along with members of the Muscogee, Seminole, Chickasaw, and Choctaw nations to migrate to the newly created Indian Territory west of the Mississippi River. This displacement along the Trail of Tears remains one of the saddest chapters in our country's treatment of Native Americans. Notwithstanding this forced migration, a significant number of descendants of the original inhabitants remain in Western North Carolina as the Eastern Band of the Cherokee Nation.

As A Declaration of Faith (1967) reminds us, "[w]e are charged to remember our past to be warned and encouraged by it, not to live it again." Today we continue our acknowledgement by specifically remembering that we live, worship and serve in the region of the Native lands of the Cherokee peoples among others; paying our respects to elders of the past and present, known and unknown. Let us do our faithful work mindful of them.

ORIENTATION

A brief time of orientation to the ZOOM meeting process was led by Ann Philbrick, Stated Clerk. For motions requiring a vote, the moderator will state the motion and the votes will be tallied by the co-hosts. Total votes for a motion will be reported back to the moderator. The orientation process was concluded after the briefing and identifying all in attendance.

APPOINTMENT OF STANDING COMMITTEES

The Presbytery of WNC conducted its 145th Stated Meeting via ZOOM, thereby eliminating the appointment of standing committees. Marie Palacios, John Pea, Bob Forsythe, and Stated Clerk, Ann Philbrick, served as Hosts/Co-Hosts in the ZOOM meeting, with Luke Johnson helping with technical matters. **Personnel Team Report
Rev. Connie Button, Chair
January 31, 2026**

Let us give thanks to God for the dedication, enthusiasm, and faithful service of all our staff to the Presbytery in 2025. The staff includes three full-time and 10 part-time committed people who serve the 89 congregations in 23 counties of western NC. It has been another year of transition as staffing positions have changed through retirements and filling empty positions, while maintaining the mission level that the Presbytery has set.

The Personnel Team is comprised of 6 men and women from around the Presbytery, ruling elders and teaching elders. They met 3 times during the year by Zoom, which allows more people from scattered locations to participate. The responsibilities include care and support of staff, annual reviews, recommending any changes in policies or job descriptions as well as terms of employment, and keeping salaries competitive. Two vacant staff positions have been filled to begin work on January 5, 2026.

During 2025, the Team conducted annual reviews for all permanent staff. Sabbatical Guidelines for ordained full-time Presbytery staff based on the COM recommendation to churches was presented and approved by COM. Salary recommendations for 2026 were also made based on COM recommendations to churches.

The Team learned during reviews with the Presbytery Associates who have assigned churches in specific areas of the Presbytery that the congregations appreciate the connections that are being made and find them helpful. One difficulty the churches in more isolated areas raised is their lack of internet service to fully participate in many Presbytery events, so in person visits and phone calls helped with that. Guatemala Coordinator shared the important connection PWNC has with the churches in Guatemala during the 30th year of ministry together. The Administrative staff was highly commended for their diligence in taking on extra duties due to changes and reduction in staff. During the year the Personnel Chair has served on Nominating/Representation Team, Coordinating Ministry and the Administrative Staffing Task Force.

In the fall, the annual Staff Appreciation Luncheon was held at FPC Morganton. Each staff member was presented with a small gift.

In the fall, the Team also considered new Board of Pensions guidelines for medical benefits as it applies to Presbytery staff. The 2026 Personnel budget request for the Team as well as all staff members was submitted to Finance through Coordinating Ministry for approval. Please be in prayer for all our staff.

The Personnel Team and Coordinating Ministry are recommending the salary packages listed in the attached document.

Housing Team

At a December Housing Team meeting, Anne Waple shared updates from the Presbytery disaster response, including housing related work being addressed by volunteers. During PWNC disaster resilience conversations planned for February, long term resilience to encourage safe, secure, affordable housing will be discussed. There is consideration for a PWNC Mission Group participating in the disaster volunteer program.

Several congregations are exploring ways to collaborate locally to identify solutions to meet needs for affordable housing, working with Helene Recovery groups, Habitat, and other grass roots groups. One community identified property adjacent to a church but discovered that location was not suitable for construction and has moved with flexibility to other options.

Identifying options and encouraging neighboring congregations to work together on projects will be a possible discussion topic at the July 2026 Neighborhood Presbytery Meetings.

September 2, 2025

We had some tech gremlins, so Chair Michael Poulos conducted a rolling, fluid call to order from 9:35-9:45. Pat gave us a thought-ful, uplifting devotion, channeling Louis Armstrong's "What a Wonderful World" and offered an opening prayer.

COM Chairperson's report (Michael)

- Approved Minutes of the August 5, 2025 meeting as modified,.
- Updated the group on Chad Smith – with Kim going on sabbatical, Keith G agreed to help as mentor.
- Update on the Board of Pensions' recommendations regarding increases to effective salaries for 2026 was given. Median has been set at \$71,100 for 2026, which is a 1.57% increase from last year's median. We approved this by an email vote in August, along with recommendations for health care coverage (same as 2025)
- Trinity's Mission Study was also approved last month by an email vote. Several people raised concerns about the first person narrative used in the Mission Study submitted by David Garnett.
- The request from Rev. Carol Ann Hoard to be received into the PCUSA was again discussed thoroughly. She is an ordained Cooperative Baptist Minister (not "Reformed") who wants to be permanently transferred to PWNC as a PCUSA Minister of Word and Sacrament. The question is HOW – through Committee on Preparation for Ministry; Receive as Temporary Member and go from there; proceed through normal process including ordination exams; OR come up with an alternate route exception (approval by 2/3 Presbytery vote required). After much discussion, it was moved, seconded, and approved for Carol Ann to plan to take the exams in the standard format AND that a small group from COM (GARY, BYRON, TOM, MEGAN) meet with Carol Ann for support and to get to know her better.
- Craig Sumey to meet with us next month for move to PWNC as member-at-large next month.
- Marcia Mount Shoop reported to Michael, Ann and Byron that Heartland Presbytery has taken disciplinary action against Rev. Jay McKell, former associate pastor at Grace Covenant. He pleaded guilty to three charges related to his boundary crossing with regards to his former church.

General Presbyter's report (Byron)

- Byron and Michael both gave updates on the very difficult situation at First Morganton. Prayers asked. Well-experienced Lance Perry has been named as Bridge Interim Pastor
- Byron has been active in the pulpits at First Morganton, Highlands, Mills River, and Marshall, including Mike McCracken's installation on 8/10/25.

Policy for use of Presbytery Hurricane Helene Relief Funds: Amended January 14th, 2026

Overview

- Purpose: We want to help churches in our presbytery who were damaged by Helene to repair their property; we want to help churches provide direct relief to their communities; and we want to provide housing and materials to work teams who come to our area.
- The fund is to be used for support of direct relief efforts as detailed hereafter in this policy
- The fund is not for salary and expenses of PWNC's Disaster Recovery Coordinator.

Categories and Process

- Churches that have incurred damage attributable to Hurricane Helene may submit requests for funding, as follows:
 - Provide receipts for repairs already made that will not be funded by FEMA, Insurance, or other parties.
 - Provide bids received for repairs to be made (at least two bids where possible) that will not be funded by FEMA, Insurance, or other parties.
 - Priority is given to this category of need. Churches may request funds for this kind of assistance up to three times each year.
 - Session shall approve the requests of their churches before they are submitted.
 - The maximum amount that can be awarded to a church in one request is \$10,000.00
 - A church can submit up to 3 requests for funding in a year, one before each of the following deadlines: March 31, July 31, and October 31.
 - A church shall indicate the date by which it expects to have distributed the funds covered by its request. Within 90 days after that date, the church shall report to the Disaster Recovery Coordinator how the funds were distributed.
 - Except under conditions of exceptional need, priority will be afforded to churches that have not already submitted multiple requests.
- Churches may submit requests for funding to provide direct relief for members and neighbors who have been severely impacted by Hurricane Helene. When funding is requested for a partner organization, the request shall still be submitted from the church and a new or existing partnership should exist between church and organization.
 - Session shall approve the requests of their churches before they are submitted.

- The maximum amount that can be awarded to a church for direct relief of members and neighbors or to existing and effective partners in one request is \$10,000.00.
 - A church can submit up to 3 requests for funding in a year, one before each of the following deadlines: March 31, July 31, and October 31.
 - A church shall indicate the date by which it expects to have distributed the funds covered by its request. Within 90 days after that date, the church shall report to the Disaster Recovery Coordinator how the funds were distributed.
- PWNC's costs of providing housing and resources for work teams that provide direct relief to churches and communities affected by Hurricane Helene.
 - Provide receipts for such costs that are not otherwise funded from other sources.
 - The maximum amount that can be awarded to a church for *housing* costs for volunteers is \$2,500.00.
 - A church can submit up to 3 requests for funding in a year, one before each of the following deadlines: March 31, July 31, and October 31
 - Cost of *materials* for work teams will be coordinated between the PWNC Disaster Recovery Team and the established work partners. After case-managed cost-estimates are provided by the work partners, and only as a cost-share, the PWNC DRT will consider requests up to \$10,000 per property for a total of no more than \$100,000 per year, and will approve and distribute on an as needed frequency.

Plan for disbursement of funds in year two:

- Priority in order indicated above in categories and process.
- 20% of available funds to Churches that have incurred damage.
- 35% of available funds to Churches to provide relief for members and neighbors who have been severely impacted by Hurricane Helene.
- 10% of available funds to costs to provide housing for work teams.
- 35% of available funds to costs to provide materials for work teams
- This policy will be reviewed after each application deadline and may be changed as needs evolve and new needs emerge.

Procedure

1. Applicants will submit requests for funding to the Disaster Recovery Coordinator. The Coordinator may request such additional information as the Coordinator thinks is necessary for the Disaster Recovery Team to make an informed decision.
2. The Disaster Recovery Team may create such forms as it believes will help it consider requests for funding.

3. The Disaster Recovery Team shall decide all requests for relief as soon as possible. Whenever feasible, the team will make a decision within 30 days of the application deadlines.
4. If available funds are insufficient to fund completely all approved requests, the Disaster Recovery Team will divide the funds as equitably as possible giving priority to churches who have submitted fewer requests. If additional funds become available, the Disaster Recovery Team can distribute them among approved requests.
5. As the Disaster Recovery Team gains experience with the process of distributing relief funds, it shall recommend to the Coordinating Ministry Team any changes to these procedures it believes will improve the process.

Communication regarding this policy

- Once approved by Coordinating Ministry on January 14, 2026, the amended policy will be communicated to all churches of PWNC.
- A form to assist churches request funding will be available and will be communicated shortly thereafter.
- Requests will be responded to as soon as possible after application deadlines.
- The Presbytery will welcome contributions to continue to grow the PWNC Hurricane Helene Relief fund and provide financial support for a minimum of 2 years. Communications about the size of the fund, the amount available to disburse and the review process will be shared widely and frequently.

STANDING RULES OF THE PRESBYTERY OF WESTERN NORTH CAROLINA

I. PRESBYTERY

A. Name. The Presbytery shall be known as the Presbytery of Western North Carolina.

B. Constitution. The Presbytery shall always operate in compliance with the provisions of the Constitution (Book of Confessions and Book of Order) of the Presbyterian Church (USA). It shall have the right to adopt Standing Rules (as a manual of administrative operations/ bylaws) that are in harmony with that Constitution.

C. Relationship to Higher Governing Bodies. The Presbytery is subject to the Synod of the Mid-Atlantic and the General Assembly of the Presbyterian Church (USA), as provided in the Constitution of the Presbyterian Church (USA).

D. Geographical Area. The geographical jurisdiction of the Presbytery includes the 23 counties of: Avery, Buncombe, Burke, Caldwell, Catawba, Cherokee, Clay, Cleveland, Gaston, Graham, Haywood, Henderson, Jackson, Lincoln, Macon, Madison, McDowell, Mitchell, Polk, Rutherford, Swain, Transylvania, and Yancey. The Presbytery may be divided into ~~clusters~~ *geographical regions*, which may serve as units for pastoral care, training, worship, and other useful purposes.

E. Incorporation. The Presbytery of Western North Carolina is incorporated as a not-for-profit corporation according to the laws of the State of North Carolina. The Presbytery of Western North Carolina and the Presbytery of Western North Carolina Corporation shall meet at the same time and place, and in the announcement of the meeting, "Presbytery of Western North Carolina" shall designate both its functions.

F. Members. All enrolled Ministers of Word and Sacrament (also known as Teaching Elders), as certified by the Stated Clerk, shall be members of the Presbytery.

II. OFFICERS OF PRESBYTERY

A. The Officers of the Presbytery shall be the Moderator, Vice-Moderator (Moderator-elect), Stated Clerk, and Treasurer.

B. Moderator's Election and Term. Each year at the third stated meeting of Presbytery, the ~~General Council~~ *Coordinating Ministry* of Presbytery shall present a nominee for Vice-Moderator (Moderator-elect). The name of the nominee will be announced in the docket packet mailed/e-mailed prior to the meeting and will be placed in nomination at the meeting. The Vice-Moderator (Moderator-elect) shall take office on January 1 following his or her election. On the next January 1, the Vice-Moderator shall become the Moderator being formally recognized at the next stated meeting of the Presbytery. The Moderator shall serve in that office for one year, or until his/her successor takes office.

C. Moderator's Duties. The Moderator shall preside at all meetings of Presbytery and perform all the duties prescribed in the Book of Order.

D. Vice-Moderator's Duties. The Vice-Moderator (Moderator-elect) shall carry out the Moderator's duties when so requested by the Moderator, or when deemed necessary by the ~~General Council~~ *Coordinating Ministry*.

E. Stated Clerk's Duties. The Stated Clerk shall be elected by the Presbytery and serve the Presbytery as its constitutional officer. The Stated Clerk shall perform those duties and functions prescribed in the Book of Order and those agreed upon by the ~~General Council~~ *Coordinating Ministry*. He or she shall annually arrange for the records of all Sessions to be reviewed. Subject to the approval of the ~~General Council~~ *Coordinating Ministry*, the Stated Clerk may appoint an Assistant Stated Clerk, whose term of service shall be the same as the Stated Clerk's. Should an investigating committee be necessary, the Stated Clerk and the chairs of the ~~General Council~~ *Coordinating Ministry* and the ~~Committee~~ *Commission* on Ministry, with consultation of the General Presbyter shall together appoint one, following the Rules of Discipline in the Book of Order. The Stated Clerk shall be elected for a term set by Presbytery, and is eligible to be re-elected.

F. Treasurer's Duties. The Treasurer shall be elected by Presbytery and have oversight of the finances of Presbytery and is responsible for ensuring that the financial policies and procedures are followed. The Treasurer shall oversee receipt and disbursement of the funds of Presbytery as authorized, keep detailed account of all receipts and disbursements and report them to the ~~General Council~~ *Coordinating Ministry* at each of its meetings and to Presbytery annually, and work with any financial campaign approved by Presbytery. The Treasurer shall be elected for a term set by Presbytery, and is eligible to be re-elected.

III. MEETINGS OF PRESBYTERY

A. Stated Meetings. The Presbytery of Western North Carolina shall *ordinarily* hold four stated meetings each year, some of which may be a part of celebrative events. The time and place shall be set by the ~~General Council~~ *Coordinating Ministry*. In the scheduling of meetings, consideration shall be given to varied geographical locations throughout Presbytery and to work patterns of participants in the meetings.

B. Special Meetings. The Moderator may call a special meeting at the request, or with the concurrence, of three teaching elders and three ruling elders, all elders being of different churches. Should the Moderator be unable or unwilling to act, the Stated Clerk may, under the same conditions, issue the call. If both Moderator and Stated Clerk are unable or unwilling to act, any five teaching elders and five ruling elders, all elders being of different churches, may call a special meeting. The synod may direct the Presbytery to convene a special meeting for the transaction of designated business. The notice of a special meeting shall be sent not less than ten days in advance to each teaching elder and to the session of every church. The notice shall set out the purpose of the meeting, and no other business than that listed in the notice shall be transacted.

C. Meetings and Invitations. Invitations to host meetings shall be received and acted on by the ~~General Council~~ *Coordinating Ministry*. Meetings, whether stated or special, may be held in-person or by virtual means. The decision about which means is to be used is made by the ~~General Council~~ *Coordinating Ministry* and communicated to all teaching elders and each session in as timely a fashion as circumstances allow. *Quorums for electronic meetings shall be the same as those described for in person meetings. If a written ballot is required or requested at a virtual meeting, a tally of the phone votes combined with the results of a published poll shall suffice.* All actions taken in meetings whether held in-person or virtually are fully authoritative, requiring no subsequent ratification.

D. Docket. The Moderator and the Stated Clerk, in consultation with the General Presbyter, shall together prepare the proposed docket for each meeting of Presbytery, which shall be approved by the ~~General Council~~ *Coordinating Ministry*. Copies of the proposed docket shall be sent electronically or be mailed to all teaching elders, clerks of sessions, and others as requested ~~at least~~ *ordinarily* ten days before

each meeting. There shall be a worship service during each meeting that shall include the celebration of the Sacrament of the Lord's Supper. The Moderator of Presbytery shall be responsible for contacting and inviting a person to preach at each worship service of Presbytery, with the concurrence of the ~~General Council~~ *Coordinating Ministry*. The preacher may be but is not necessarily the pastor of the host church. Ordinarily, the pastor and session of the host church participate in this worship service. Memorials for church professionals and ruling elders who have died in the preceding twelve months shall be included in the worship service of one stated meeting each year.

E. In order to ensure fairness and access to all necessary information, any new business to be dealt with at a Presbytery meeting, not arising from a Presbytery ~~committee~~ *ministry, team, or commission*, shall be submitted to the Stated Clerk for inclusion in the packet no later than thirty days before the scheduled meeting of Presbytery. By a two-thirds affirmative vote, however, Presbytery may decide to consider other new urgent business, if brought to the Stated Clerk before ~~10:00 a.m.~~ *at the beginning* of the Presbytery meeting. This new business shall be referred to the Bills and Overtures Committee for report later in that meeting.

F. There shall be no distribution of materials at Presbytery meetings without prior approval from the ~~General Council~~ *Coordinating Ministry*.

G. Rules of Procedure. The rules that shall govern all the transaction of business in all meetings of Presbytery shall be in accordance with the Constitution of the Presbyterian Church (USA), these Standing Rules (bylaws), and the most recent edition of Roberts Rules of Order, Newly Revised.

H. Attendance and Voting. Each *Minister of Word and Sacrament* (teaching elder) shall attend each meeting of Presbytery, and each congregation shall be represented by at least one ruling elder at each meeting. Congregations are entitled to ruling elder commissioners based on the following active membership (BO: G-1.0402), as shown on the most recent statistical report *published by the General Assembly*.

- 0 - 250 members - 1
- 251 - 750 members - 2
- 751 - 1250 members - 3
- 1251 - 1750 members - 4

Honorably retired teaching elders shall be welcome at all meetings, but their necessary non-attendance shall be excused.

To ensure approximate parity in numbers between ruling elder and teaching elder commissioners:

1. All members of the ~~General Council~~ *Coordinating Ministry* and ~~Committee~~ *Commission* on Ministry shall have voice and vote (if ruling elders).
2. All ~~division, committee and sub-committee~~ *ministry, team, and commission* chairs shall have voice and vote (if ruling elders).
3. All Commissioned Pastors in active service shall have voice and vote.
4. All Certified Christian Educators, Certified Associate Christian Educators, and, in addition, other Christian Educators who have
 - earned at least a bachelor's degree (or its equivalent)
 - served in one or more educational ministries under the jurisdiction of a Presbytery (or

one of its Sessions) for a minimum of two (2) years, and

- been examined and recommended to Presbytery by the ~~Christian Education Committee~~ *Faith Formation Team* shall have voice and (if ruling elders) vote, provided that these privileges shall end, pursuant to ~~BO: G-2.1103~~, when such persons are no longer serving in an educational ministry under the jurisdiction of the Presbytery (or one of its Sessions).

5. All ruling elder commissioners to the Synod Assembly and to the General Assembly shall have voice and vote as long as their terms last.

6. All exempt staff of Presbytery shall have voice.

7. All racial/ethnic congregations and other congregations designated by the ~~General Council~~ *Coordinating Ministry* shall elect an additional ruling elder commissioner.

8. ~~Only All Ministers of Word and Sacrament (or Teaching Elders) who are active members (including honorably retired teaching elders) or members at large of Presbytery, as defined by the Book of Order, enrolled with the presbytery shall have voice and vote.~~

I. The quorum for stated meetings of Presbytery shall be at least fifty commissioners including twenty *Ministers of Word and Sacrament* (Teaching Elders) and ruling elders commissioned by at least twenty sessions. The quorum for special meetings shall be half of the above.

J. Corresponding Members and Visitors. The Presbytery may give voice but no vote to any of the following:

- Official representatives from the Synod or the General Assembly.
- Teaching or ruling elders from another presbytery, a Reformed Church in communion with the Presbyterian Church (USA), or any other Christian church.
- Or those others approved by a $\frac{3}{4}$ vote of Presbytery.

Other visitors are welcome to attend as observers, unless the Presbytery, for good reason, votes to go into executive session.

IV. PRESBYTERY ~~GENERAL COUNCIL~~ *COORDINATING MINISTRY*

A. Purpose. The ~~General Council~~ *Coordinating Ministry* shall ensure that the priorities of Presbytery are carried out by the ~~Divisions, committees, and other units~~ *ministries, teams, or commissions*, as well as the staff of Presbytery, and that these priorities are reflected in the Presbytery budget. It shall coordinate the many parts of Presbytery to contribute to the life and witness for Christ of the whole Church. It shall foster positive attitudes within the Presbytery and encourage its members to engage in regular prayer regarding the mission of the Presbytery of Western North Carolina, the Synod of Mid-Atlantic, the General Assembly and the whole Presbyterian Church (USA). The ~~General Council~~ *Coordinating Ministry* is the servant of Presbytery and has only those powers provided by these Standing Rules or authorized by Presbytery.

B. Membership. The ~~General Council~~ *Coordinating Ministry* shall be composed as follows:

1. Voting Members

- Immediate Past Moderator of Presbytery, who shall serve as chair for one year *and as President of the Corporation*.

- Moderator of Presbytery, who shall serve as vice-chair for one year *and as Vice-President of the Corporation.*
- Vice-Moderator (Moderator-elect) of Presbyter, who may serve as secretary.

- Six at-large members, nominated by the Nominating/Representation ~~Committees~~ *Team* (giving due consideration to geography and experience, with equal number of teaching and ruling elders) and elected by Presbytery, serving three-year staggered terms (two on, two off each year). These may be nominated and elected for an immediate second three-year term, after which they may not serve on the ~~General Council~~ *Coordinating Ministry* for at least one year before being eligible again.

2. Non-Voting Members*

- General Presbyter
- Stated Clerk, *who shall serve as Secretary of the Corporation.*
- Any staff of Presbytery chosen by the General Presbyter

C. Leadership Team. The chair (Moderator of ~~General Council~~ *Coordinating Ministry*), vice-chair (Moderator of Presbytery), Vice-Moderator of Presbytery, secretary of ~~General Council~~ *Coordinating Ministry*, two at-large members elected from the ~~General Council~~ *Coordinating Ministry*, the General Presbyter and the Stated Clerk shall form a leadership team for the ~~General Council~~ *Coordinating Ministry*, whose duties shall be to

- Make preparations for each meeting of the ~~General Council~~ *Coordinating Ministry*
- Submit recommendations to the ~~General Council~~ *Coordinating Ministry*
- Carry out assignments given by the ~~General Council~~ *Coordinating Ministry*
- Take appropriate action on urgent matters that cannot wait for the next ~~General Council~~ *Coordinating Ministry* meeting, such action to be reported at the next meeting

D. Functions: The ~~General Council~~ *Coordinating Ministry* shall have the following responsibilities:

1. To lead Presbytery in setting appropriate goals in accord with its Mission Statement.
2. To coordinate the mission and programs of Presbytery.
3. To review the work of all ~~Divisions, committees and other units~~ *ministries, teams, and commissions* of Presbytery, offering helpful advice as warranted.
4. To approve the proposed annual budget prepared by the ~~Administration Division~~ *Finance Team* ensuring that Presbytery's priorities are reflected therein, for submission to Presbytery; and to make adjustments to the budget approved by Presbytery, provided that such are reported to the

next meeting of Presbytery.

5. To refer work to, and to hear recommendations from, the ~~Divisions, committees and other units~~ *ministries, teams and commissions* of Presbytery.

6. To approve the proposed docket for the Presbytery meetings prepared by the Moderator and Stated Clerk, in consultation with the General Presbyter, and have oversight of worship at Presbytery meetings.

7. To serve as the Board of Trustees of the Presbytery Corporation, with the right to designate some of their members to exercise that responsibility on behalf of the ~~General Council~~ *Coordinating Ministry*.

8. To consider requests from congregations regarding the exercise of their property rights under G-4.0206 in the Book of Order, and recommend appropriate actions to Presbytery.

9. To recommend persons for the Nominating/Representation ~~Committees~~ *Team* of Presbytery, and for the offices of Vice-Moderator (Moderator-elect) and if necessary, Moderator.

10. To approve the appointment of persons by the Nominating / Representation ~~Committees~~ *Team* to fill vacancies ~~on committees~~ in cases of emergency (subject to ratification by Presbytery).

11. To act as a hearing board in personnel matters which may be appealed from the ~~Administration Division~~ *Personnel Team*.

12. To refer actions of the General Assembly and Synod to ~~Divisions and committees~~ *ministries, teams and commissions* for study and interpretation.

13. To keep Presbytery informed of its work through reports at each meeting.

14. To review Presbytery's fulfillment of its responsibilities listed in the Book of Order (G-3.03).

15. To authorize celebrations of the Sacrament of the Lord's Supper at retreats, camps, conferences and special gatherings under the jurisdiction of Presbytery.

16. To recommend personnel policies to Presbytery for all its employees, which shall embody the inclusiveness required in the Book of Order.

17. Between meetings of Presbytery, to act on behalf of Presbytery in urgent matters by a two-thirds majority vote, provided that a full report of such action is given to Presbytery at its next meeting.

B. General Regulations:

1. Subject to the approval of Presbytery, the ~~General Council~~ *Coordinating Ministry* shall determine the general responsibilities and the number of members of each ~~Division~~ *ministry*.
2. Working with the ~~General Council~~, *Coordinating Ministry*, each ~~Division~~ *ministry* shall determine the ~~committees/sub-committees~~ *teams* it deems necessary, as well as the number of members and the duties of each.
3. ~~Members of the Divisions and committees shall be nominated by the Nominating and Representation Committees and elected by Presbytery. Members of the sub-committees shall be selected by the Nominating/Representation Committee or the relevant Division and confirmed by the General Council. Normally, no more than half of these members should be teaching elders.~~
3. *Equipping Ministry, Strengthening Congregations Ministry, and Engaging in Mission Ministry shall be composed of three members, each on a staggered three-year term. The member in their final year of service shall serve as the liaison to the Coordinating Ministry. These ministry members shall be nominated by the Nominating/Representation Team and elected by presbytery. All teams and team leaders under these ministries shall be recruited and appointed by the ministry itself. Normally, no more than half of each team should be teaching elders.*

Coordinating Ministry is defined by its section of these Standing Rules. Supporting Leadership

Ministry shall be made up of representatives of the constituent teams and commissions. All members of its teams and commissions shall be nominated by the Nominating/Representation Team (with the exception of the SMRT) and elected by presbytery.

4. Normally, ~~members of the Divisions and committees~~ *those members elected to teams or ministries* shall serve a three-year term, may be re-elected, but may not serve more than six consecutive years, after which they may not serve on the same body for at least one year before being eligible again.

5. All ~~Divisions and committees~~ *ministries and teams* should report to Presbytery through the ~~General Council~~ *Coordinating Ministry* to enable it to coordinate activities in Presbytery. The ~~General Council~~ *Coordinating Ministry* may not alter any ~~Division or committee~~ *ministry or team* report, but may offer advice to Presbytery concerning ~~Division or committee~~ recommendations.

6. ~~Divisions and committees~~ *Ministries and teams* shall develop and implement plans and programs that carry out their goals as adopted by Presbytery, and evaluate and report to Presbytery their activities annually. ~~Some committees may need to meet as a whole only a few times a year, with sub-committees working on specific tasks during the rest of the time.~~ *Divisions and committees* Ministries and teams may also meet *in-person*, by telephone conference, emails, *web-based conferencing* or other suitable methods.

7. ~~Divisions and committees~~ *Ministries and teams* shall be encouraged to be creative and to explore new avenues of ministry with accountability to Presbytery through the ~~General Council~~ *Coordinating Ministry*.

8. ~~Divisions and committees~~ *Ministries and teams* shall annually submit their budget requests to the ~~Administration Division~~ *Finance Team*. They shall carry out their responsibilities within the approved budgets, unless an overrun is approved in advance by the ~~General Council~~ *Coordinating Ministry*.

9. Ordinarily, a person may serve on only one Presbytery ~~Division or committee~~ *ministry, team or commission* at the same time. Normally, there should not be more than one representative of any one church on the same Presbytery ~~Division or committee~~ *ministry, team, or commission* at the same time (except congregations having more than two hundred active members may have more than one representative on the same committee).

10. ~~Divisions and committees~~ *Ministry and team* chairs will contact any *elected committee* member after three meetings in a year have been missed (without a reasonable excuse approved by the ~~committee~~ *team*) and inquire as to their ability and willingness to serve at this time, and will advise the ~~committee~~ member that a further unexcused absence will result in removal from the ~~committee~~ *team*. It will be the responsibility of the ~~committee~~ chair to inform the Nominating/Representation ~~Committee Team~~ when members have missed half of the ~~committee~~ meetings and the Nominating /Representation ~~Committee Team~~ shall replace such members as soon as possible.

11. Terms of office for ~~Division and committee~~ chairs shall be one year, with no chair serving more than two consecutive terms. Each *electable committee* chair shall be nominated specifically for that position by the Nominating/Representation ~~Committee Team~~, but still be from the total membership of the ~~committee team~~. In extenuating circumstances, an additional year as chair may be recommended to ~~General Council~~ *Coordinating Ministry*.

~~13.~~ 12. ~~Divisions and committees~~ *Ministries and teams* are encouraged to suggest to the Nominating/Representation ~~Committee~~ *Team* suitable persons for new members and new chairs.

Each ~~committee~~ *ministry* may, on its own initiative, create one or more on-going ~~working groups~~ *teams* for long-term projects or ~~temporary task forces~~ for specific short-term projects. ~~Both working groups and task forces will report to the creating committee.~~ When a ~~task force~~ *such a team* has completed its assignment, it shall cease to exist. ~~15.~~ 14. Each ~~Division and committee~~ *ministry and team* shall keep accurate minutes. Copies of all minutes, and reports should be submitted to the ~~General Council~~ *Coordinating Ministry* on a regular basis.

~~16.~~ 15. The quorum for each ~~Division and committee~~ *ministry or team or commission* shall be a majority of its members.

~~17. Sub-committees should comply with all the above regulations and shall report to the Division and General Council through their committees.~~

VI. NOMINATING/REPRESENTATION TEAM

The Nominating/Representation Team shall consist of fifteen (15). It shall be broadly representative of the member churches of the Presbytery. Ordinarily, one-third of its members shall be ministers, one-third laywomen, and one-third laymen (youth to be included among the laity). There shall be racial/ethnic representation of up to twenty-five percent, whenever possible. Nominees for vacancies on the Nominating/Representation Team and its moderator shall be made to Presbytery by the Coordinating Ministry.

VII. COMMISSION ON MINISTRY

A. Purpose and Authority: The purpose of the Commission on Ministry is to enable the presbytery to fulfill the responsibilities and powers assigned the presbytery by G-3.0301, 3.0303, 3.0306, and 3.0307, and may function as a commission of the presbytery when engaged in carrying out the following functions:

- *Examining and receiving Ministers of Word and Sacrament into membership or temporary membership in the presbytery;*
- *Approving calls and changes in terms of call;*
- *Creating or dissolving pastoral relationships in a church;*
- *Approving contracts for temporary pastoral positions;*
- *Approving commissioned pastor contracts;*
- *Validating ministries;*
- *Appointing ordination and installation commissions;*

APPENDIX M

- *Appointing session moderators;*
- *Setting minimums for terms of call and contracts;*
- *Settling difficulties (respecting G-2.0901);*
- *Giving permission for ministers not serving a congregation to celebrate the sacraments;*
- *Dismissing a minister in good standing from the presbytery;*
- *Approving ministers to the status of Retired;*
- *Visiting congregations reported to be affected with disorder, inquiring into and offering support to settle difficulties.*

All such actions are reported to the next meeting of the presbytery. In cases of disagreement, appeals can be made to the next presbytery meeting.

B. Membership: The Nominating/Representation Team shall nominate and the Presbytery shall elect a COM of no fewer than eighteen (18) members with teaching elders and ruling elders in nearly equal numbers as possible. Members shall be divided into three equal classes. Members shall normally be elected to a three-year term and may be re-elected to a second full or partial term. No member may serve more than six consecutive years.

C. Subteams: The Nominating/Representation Team shall nominate and the presbytery shall elect members of the COM Subteams of Examinations and Validation of Ministry. COM shall determine the number of members needed. Members shall be divided into three equal classes. Members shall normally be elected to a three-year term and may be re-elected to a second full or partial term. No member may serve more than six consecutive years.

VIII. PERMANENT JUDICIAL COMMISSION

A. Purpose and Authority. The Permanent Judicial Commission has the powers prescribed by and conducts proceedings according to the Constitution of the Presbyterian Church (U.S.A.) as found in the Book of Church Discipline.

B. Membership and Officers. The Nominating/Representation Team shall nominate and the Presbytery shall elect a Permanent Judicial Commission of no fewer than seven (7) members with teaching elders and ruling elders in nearly equal numbers as possible. Members shall be divided into three equal classes. Members shall normally be elected to a six-year term and may be re-elected to a second full or partial term. There shall be no more than one member from any one church on the commission. The Commission shall elect it's own moderator and clerk from its membership.

C. Procedure and Responsibilities. Membership, procedure, powers and responsibilities are those contained in the Book of Order, the Church Discipline.

IX. SEXUAL MISCONDUCT RESPONSE TEAM

A. Definition and Purpose. The SMRT is charged with providing pastoral care, support, and advocacy where needed in cases involving accusations of sexual misconduct within the Presbytery. The purpose of the SMRT is to assure that an expeditious, professional, objective, effective, and caring response is made by the Presbytery to charges of sexual misconduct. This team shall not investigate allegations or

in any way function as an investigating committee for disciplining members or officers but shall confine itself to coordinating a process that shall meet the specific needs of the accuser and their family (if any), the victim (if not the accuser) and their family (if any), the accused person and their family (if any), employing entities, congregations, and councils.

B. Membership. There shall be at least six members of the SMRT, each appointed for a three-year term by the COM. The Team shall elect its own Moderator. It shall be composed, as nearly as possible, of an equal number of clergy and ruling elders. Members may serve no more than six consecutive years.

C. Activation. The SMRT shall be activated whenever an allegation of sexual misconduct is received by the Stated Clerk, or when deemed appropriate by the COM Moderator in consultation with the Stated Clerk.

~~VI.~~ X. PRESBYTERY STAFF

Presbytery shall hire staff as required to fulfill its mission and responsibilities. The General Presbyter shall be head of staff. Staff shall be responsible to Presbytery, reporting through the ~~General Council~~ *Coordinating Ministry*, and not be responsible to a single ~~Division or committee or sub-committee~~ *ministry, team or commission*. ~~All Divisions, committees, and sub-committees shall have support and resourcing.~~ *Coordinating Ministry, with the guidance of the Personnel Team, shall determine all support and resourcing from staff for ministries and commissions and teams.* The “Personnel Manual of the Presbytery of Western North Carolina” provides guidelines and policies for hiring, supervising and terminating staff, and for the provision of salary and benefits.

~~VII.~~ XI. AMENDMENT

These Standing Rules for the Presbytery of Western North Carolina shall be periodically reviewed by the ~~General Council~~ *Coordinating Ministry*, with any changes recommended to Presbytery. Such proposed amendments may be adopted by a two-thirds vote of those present and voting at any stated meeting of the Presbytery.

APPENDIX O

Brief Biography of Jim Ewing

I was born and raised in Charlotte, NC. My parents were married at Covenant Presbyterian Church where I was baptised and confirmed. Covenant was a spiritually nurturing place where I grew in my faith and understanding of God. I learned scripture and Christian History, which became foundational for my faith later in life. At Covenant, close friendships were fostered that I continue to cherish to this day. It provided a faith community where I could explore and deepen my faith journey.

During college, I learned how to take that relational faith experience and find community with other peers from different theological backgrounds. When I returned to Charlotte after college, I was invited to help with the Youth Program at Covenant and participate in Christian Education programs that once again deepened my relationship with scripture and other members.

It was during that time that the ministers of the church invited me to consider ministry as a vocation. Like most, I was reluctant at first, but they were patient and helped me to see that God uses all sorts of people for God's ministry in the world. So I toured and applied to different Presbyterian seminaries and was led to Union in Richmond. From there God has called me to marriage, fatherhood, and a wonderful vocation as minister of Word & Sacrament. In addition to family, I have had the joy of serving at St. Andrews Presbyterian College, Community Presbyterian Church, and Avondale Presbyterian Church. Each call has brought with it the joy of living life in a faith community that allows me to *be* nurtured as much as I'm called to nurture. Certainly each place has had challenges which have led to personal growth and development. However, at every milestone, crossroad, and discernment opportunity, I have experienced God's sovereignty and presence. Naturally this fills me, time and time again, with gratitude and praise for our God who shows us divine love through the life and resurrection of Jesus.

Statement of Faith **Rev. Jim Ewing**

Theology

I believe in God who has created and who is creating. I believe in Jesus Christ, Emmanuel, God with us. I believe that ultimately our hope in life and in death rests in God's loving sovereignty that is shown to us through the life, death, and resurrection of Jesus Christ. I believe that through the work of the Holy Spirit we can learn about the nature of God's love for creation found in the unique scriptures of the Old and New Testament, and that with the help of the Holy Spirit we learn to follow Jesus by loving God and loving our neighbor. (BOC 11.5)

Scripture

One aspect that I have appreciated about our faith is that it has transpired over thousands of years. One of the connecting threads, for me, has been the unique and holy scriptures that are found in the Bible. It is a powerful thought for me that if I was worshipping in 1025 AD or worshipping 2025 AD, God would be revealed through God's Word which would be shared to those gathered on that day. (BOC 9.27)

Sacraments

In those same ancient words we hear Christ commanding his followers to participate in the Lord's Supper and to Baptise. I have always been taught and have come to appreciate how these Sacraments are for us "holy signs and seals of the covenant of grace." (BOC 6.149) At the table we are given a spiritual food that nurtures us, sustains us, and reminds us of God's love for us. We are claimed by God in the waters of Baptism and that nothing in life or in death will ever separate us from that love of God. (BOC 9.51 - 9.52; 11.5)

Polity

I have always been grateful for the Presbyterian tradition which, from birth, has provided a safe place for me to learn, grow, practice, and serve in the faith. I am grateful that our Presbyterian tradition recognizes the privilege of ministry for all members and not exclusively for clergy. For me, that understanding unifies the church as truly being the body of Christ (BOC 9.4). I am grateful that we do not boast to be the only church, but a part of the greater apostolic church (BOC 1.3). I believe that when people of faith are in relationship with one another, they can truly encourage each other in their faith journeys. As Jesus reminds us, "wherever two or three are gathered together in my name, I am there in the midst of them" (Matthew 18:20). With Christ in our midst, we can support and build up the body of Christ together to serve God. (BOC 9.36)

APPENDIX P

Jess Rigel - Biography

I was raised a child of Pennington Presbyterian Church, a historic, vibrant congregation near the Delaware River in New Jersey. I came to the church through grief; when I was five, my older brother Josh was killed by a drunk driver. Our parents had been church-hopping at the time and were not members of any congregation, but when my brother died the local Presbyterian Church overwhelmed my family with much needed practical support, and thus, I became a Presbyterian. I grew up attending weekly services and participating in youth group, confirmation, and mission trips, but I only became comfortable calling myself a Christian in college. It was there that I realized there were a variety of interpretations of Christian belief, many of which differed vastly from my own. I became a religion major to more deeply explore this reality, yet found myself drawn to other traditions, particularly Buddhism, which prompted me to study for a semester in Northern India. My experiences there forever changed my relationship with God.

In India, I began to study and practice meditation as a form of contemplative prayer, which opened my heart to a deeper awareness of Divine love and peace. I returned to the U.S. with a stronger commitment to Christ than I'd ever had before, which eventually led me to the PC(USA) Young Adult Volunteer program, where I served as a land steward in southern Arizona and as a community gardener in New Orleans, Louisiana. Each of my YAV years significantly impacted the way I interact with God's good creation and the way I understand Jesus, justice, and Christian community.

It was during my time as a YAV in New Orleans that I was encouraged to pursue Seminary, and though I was hesitant, I trusted the movement of the Spirit and was accepted at Princeton Theological Seminary in 2014. Entering with no intention of becoming a pulpit pastor, I was shocked when my studies led me to fall in love with coursework in Hebrew Bible, Practical Theology, and Preaching. Through field education, I was blessed to practice ministry as both a college chaplain and a pastor for young adults, and through CPE I was able to serve in both traditional hospital and behavioral healthcare settings. It was these experiences that guided me to accept my call to parish ministry.

Upon graduating from Seminary, I was ordained and installed as the Discipleship Pastor of Alamance Presbyterian Church, a mid-sized, PC(USA) congregation in Greensboro, North Carolina. At Alamance, in addition to mission work, preaching, teaching and pastoral care, I focused primarily on programming opportunities for children and youth. Through this focus I particularly grew in my understanding of how youth & children process grief, as well as my awareness and response to body image and disordered eating issues. I loved my time at Alamance, and am excited to follow my call to Western North Carolina, where I hope to continue to grow in relationship with Christ and lead others to Christ through serving His people.

Jess Rigel – Statement of Faith

Our God is one – the Creator, Redeemer and Sustainer of all, who remains ever present with creation, refusing to abandon it. (10.1, Belhar) God relishes beauty, and embodies grace, forgiveness, and absolute love, such that, though God has the authority to control everything, God instead empowers humanity and creation with the agency to choose or ignore God of their own volition. Jesus Christ, God's son yet God's self, emerged from Mary's womb fully human while remaining fully Divine. This Jesus loved, laughed, healed, suffered, died, and had the audacity to return from the dead through the power of God to demonstrate His love for humanity. (2.2, Apostles' Creed) I trust in the Holy Spirit, and I live in awe of the way I glimpse the Spirit working through lives, including my own. I believe that the Spirit is not always gentle, but is persistent, committed to enriching lives to find the wholeness, fulfillment, and peace of Christ and to become reflections of God's grace. (9.20, 1967)

I believe in the authority of Scripture, which serves as a witness to God's great love. Scripture reflects the intended relationship between God and the created order, and it revolves around human stories as a means of helping believers understand, grow and persevere in their relationship with the Divine. (6.006, Westminster) Through studying and struggling with these writings, we can become more faithful to living in the ways of Christ, whose commitment to prayer, presence, and service is embodied throughout the Gospels. (9.29, 1967) To be a disciple of Christ is to submit to such spiritual practices with a grateful heart. (9.30, 1967)

I believe that the sacraments manifest the grace of God through their focus on our unity and humility before Christ in worship. In baptism and communion, communities of faith engage Christ's power through dying to their own sin and being resurrected to a relationship with Him rooted in sustenance and fellowship. By practicing these sacraments, believers experience God's healing presence in our daily lives and recommit ourselves to the kingdom vision of the beloved community. (4.073, 4.075, Heidelberg)

I believe that the Church was formed to manifest the grace of God. (8.17, Barmen) As a human institution, this catholic vision fractured, yet has remained a powerful force, often for good, sometimes for ill. (9.34, 1967) I trust in the tenets of the Presbyterian faith as a means of organizing followers of Christ in service and worship, and better understanding the work and witness of the Church in the world. I believe PC(USA) polity strives to create equity, structure, and accountability for the community of Christ it seeks to serve. When grounded in humility and welcome, the Church can offer glimpses of God's kingdom on earth. (9.40, 1967)

Our Triune God redeemed the world and continues to redeem it through abounding grace. (9.15, 1967) When we open our hearts to welcome the Holy Spirit, we are transformed and empowered to walk beside all who suffer. Through grace, we become Christ's hands and feet in the world until He comes again. (10.7, Belhar; 8.16, Barmen)

THE PRESBYTERY OF WESTERN NORTH CAROLINA PREPARATION FOR MINISTRY Kelley Connelly, Chair January 31, 2026

The Preparation for Ministry Team recommends the following to the Presbytery of Western North Carolina:

RECOMMENDATIONS:

1. THAT Susie Burns, an inquirer from Black Mountain Presbyterian Church in Black Mountain, NC, and a student at Union Theological Seminary in Charlotte, North Carolina, be enrolled as a Candidate following the required examination by Presbytery.
2. THAT Mary Taneti, an inquirer from First Presbyterian Church in Gastonia, NC, and a student at Union Theological Seminary in Charlotte, North Carolina, be enrolled as a Candidate following the required examination by Presbytery.

Recently, your Preparation for Ministry Team conducted separate interviews with two Inquirers who asked, with the support of their sponsoring congregation and Session, to be enrolled as a Candidate in the Presbytery of Western North Carolina. We recommend Susie Burns and Mary Taneti to you today for approval.

Susie comes with the support of her congregation and the recommendation of the Session of Black Mountain Presbyterian Church in Black Mountain. Her written call to ministry/faith statement is contained in this packet (PMT Attachment 1).

Mary comes with the support of her congregation and the recommendation of the Session of First Presbyterian Church in Gastonia. Her written call to ministry/faith statement is contained in this packet (PMT Attachment 2).

The Process of Becoming a Candidate and Beginning to Receive a Call

“It is important that those who are to be ordained as teaching elders receive full preparation for their task under the direction of the presbytery. For this purpose, a presbytery shall enter into a covenant relationship with those preparing to become teaching elders and with their sessions and congregations. This relationship shall be divided into the two phases of inquiry and candidacy.” (Book of Order G-2.0601)

Inquiry Phase:

In order to begin the inquiry phase, an applicant must be a member of the sponsoring congregation, shall have been active in the work and worship of that congregation for at least six months, and shall have received the endorsement of their session. This person is then examined by PMT, and if approved, is enrolled as an Inquirer.

“The purpose of the inquiry phase is to provide an opportunity for the church and those who believe

themselves called to ordered ministry as teaching elders to explore that call together so that the presbytery can make an informed decision about the inquirer's suitability for ordered ministry." (G2.0603) A person must be an Inquirer for at least one year.

Candidacy Stage:

When an Inquirer believes, through their discernment, that they are called to the position of teaching elder, they can request that they become a Candidate. The Inquirer will meet with their Session and explain their sense of call. The Session can endorse them and recommend them to PMT. The PMT, through its discernment, can decide to recommend them to the Presbytery. At the recommendation of PMT, the Inquirer comes before the Presbytery to share part of their faith journey and their sense of call. The Presbytery can then ask questions in respect to their sense of call, not questions of content of an ordination exam. They can ask about "their Christian faith, forms of Christian service, and motives for seeking the ministry." (Adopted from a previous Book of Order.)

"The purpose of the candidacy phase, then, is to provide for the full preparation of persons to serve the church as teaching elders." (G-2.0604)

Preparation for a Call:

Before a person may take a call in our Presbytery, they must have completed the following:

- Pass the Bible Content Exam.
- Pass the four Senior Ordination Exams (Biblical Exegesis, Theological Competence, Worship and Sacraments, and Church Polity).
- Complete a two-day battery of assessments administered by a Career & Personal Counseling Center.
- Complete one unit of Clinical Pastoral Education training (CPE).
- Normally, complete at least one year at a PCUSA seminary.
- Meet annually with the Preparation for Ministry Team.
- Have been an Inquirer at least one year and have been a Candidate at least one year.
- Take a course in Reformed Theology and Polity.
- Complete Seminary.

Must be Approved by PMT to Receive a Call:

A Candidate may not begin to enter negotiations about a call as a teaching elder without the approval of PMT, which has been delegated this task. When a Candidate has completed the above, the PMT will examine the Candidate and determine if he/she is ready to begin looking for a call, and if so, will "certify the person ready to receive a call." The Candidate will also have their Personal Discernment Profile (PDP) reviewed and approved by PMT. When the person receives a call, the Candidate will be examined by the receiving presbytery.

If a Candidate who is under care of this Presbytery receives a call within our bounds, that Candidate will preach before the Preparation for Ministry Team and their sermon will be included in the Presbytery report.

Susie Burns
Statement of Call

Dear Members of the Presbytery of Western North Carolina,

I am incredibly grateful to each one of you and the many ways that my faith has been strengthened as I continue the journey to be faithful where God continues to lead. I am deeply aware that we are called to community together and it is in that community that we are shaped and formed by our love first to God and to each other.

Throughout my life I have been blessed to experience deep friendships that continue to nurture me along as I formally pursue my Master of Divinity as I seek God's call on my life. It's been somewhat of a miracle given that I did not graduate College. I graduated one year early from a small rural high school because I was going to work in floral design and marry my childhood sweetheart. Further education was not supported by my family or needed to fulfill these goals, so I got a jump start on feeling more secure by financially supporting myself.

Many religious communities have shaped my ecclesiastical journey. I was baptized and confirmed in my family's Methodist church. I experienced a sense of wonder and safety there and through my grandmother, whose message of love was contrary to wrathful church messages. When my grandmother passed away, so did my sense of safety in the church. I began to feel more alienated than loved and forgiven.

I was married and divorced at an early age and spent most of my young adult life outside of organized religion. I visited many churches that left me feeling vulnerable, excluded and judged because I was an unwed mother with many gay friends. One of my dearest friends had AIDS and feared that God would subject him to a fiery pit of Hell. I wanted to belong to a community that would welcome him too.

Eventually, I married Bob, who became a father to my 12-year-old daughter. The subsequent births of our two boys inspired us to search for a faith community. We landed in a Unity Church because of the solace I had found in their daily devotion, *The Daily Word*. This was a safe, inclusive, authentic place of healing for both of us.

On February 19, 2001 my life was abruptly interrupted when I found that Bob had died in the early hours of the morning. The following days were filled with the unspeakable. The pastor who was working with Bob to plan our sons' baptism was now working with me to plan Bob's funeral. I was filled with a divine presence that can only be described as God's grace. We decided to incorporate the baptism as a part of Bob's celebration.

I knew that God was present in my life and in the lives of my children. My church community enveloped me as I grieved and healed old church wounds. I volunteered there and eventually become Director of Youth and Families. Though I had not formally studied scripture, I moved forward prayerfully in my intention to serve God. The program grew from a few children and youth to 125 every week. This was built out of the love that comes when a church family stands together in community,

they faithfully live into their Baptismal vows. They loved God deeply along with loving each other to live into a life of Christian service. I could sense God's call and the deep abiding love that was growing in my heart. I began to consider the path of theological education.

I asked my architect friend, Wade, to visit my church and advise us about the best use of our small space. As his brief trip progressed, we became aware of our mutual love. A month later, he proposed, and I traveled to his home in Montreat to discuss wedding details. We sat on top of the hill where we built our first home and took in God's beauty, and I knew God was calling me to something more.

Montreat became my home, and I came to understand it as "a thin place," where the veil between heaven and earth is almost nonexistent and people of faith gather to rest, renew, and listen for God's call. This was my first exposure to the PC (U.S.A.). We joined Black Mountain Presbyterian Church, and I connected with others who were also searching, questioning, and seeking out the sacred in everyday life.

As Director of Church Relations for Montreat Conference Center, I had an incredible opportunity to serve and walk with many different congregations across the United States. I would travel to share Montreat's ministry with churches across the country. I experienced throughout those years a deep longing to serve and love people. One of the most profound experiences I had during my time at Montreat as it relates to my call was several years back when I was worshipping at The Church of the Master in Atlanta, GA. I experienced what can only be described as a gentle nudging from the Holy Spirit to explore Theological Education. I had the gift of walking with wonderful Mentors throughout the years since that initial nudging. As I reflect on those moments of the Holy encounters of deep knowing, I am grateful for all the wonderful communities of faith walking with me.

I have always prayerfully sought the guidance of the Holy Spirit as I have moved through my discernment process. It has been one filled with moment of surprise and wonder. As I first started the process of ordination, I would have thought I would be ordained into my role at Montreat, serving many of the congregations across the Denomination. And yet, as I walked through my Supervised Ministry, I knew God was calling me to congregational ministry. I am deeply grateful. I am currently in the final portion of my educational process. This upcoming spring, I will be completing the requirements for CPE along with my final required classes. With God's guidance and support, I will be graduating from Union Presbyterian Seminary in Charlotte in June 2026. I have recently taken a position as the Pastoral Resident for First Presbyterian Church, Hartsville, SC. I look forward to serving the families and children and walking with the congregation as we live faithfully into our Baptismal vows.

My name is Mary Taneti, and I grew up in South India before moving to the USA with my family in 2005. As a child, I imagined God's call would be dramatic—lightning or a booming voice—but it was subtle. There was no defining moment, no grand promise, and no stars to count as with Abraham. Still, the journey into the unknown was quietly shaped by faith and circumstance. My parents were faithful churchgoers, starting at an early age my parents taught me to attend church, study the Word, and pray. My father served in the Indian Navy and was an active elder in his church for several years. He demonstrated fair leadership and dedication to work. My mother taught in school and took me along with her to work. I saw her work patiently and with tremendous love for her work and the children she served. This early exposure laid the groundwork for my lifelong dedication to service and faith.

As the third of five children, I earned a master's in financial accounting and supported rural women in South India by working for a microfinance company. I became active in my own church and volunteered extensively. From my microfinance work, I admired the resilience of the women I served. Their stories fueled my belief in the transformational power of education for Indian women and clarified my calling. When I married James—now a PCUSA minister and seminary professor—my commitment found new avenues. Joining his family of ministers made it natural to support and engage in church work, continuing the journey my parents began. Later, like many Indian women, I left my profession to become a full-time wife and mother, uncertain of the future.

After my career in microfinance ended, my family, James, my two young children, and I immigrated to the USA when my husband entered. In the new country, I cared for them and also sought a greater purpose. I joined a Bible Study Group for seminary spouses and audited classes,

which the seminary welcomed. Inspired by this community and conversations with loved ones, I felt called to study Scripture. Encouraged by acceptance and financial aid, I began a new path. I enrolled in the Master of Arts in Christian Education program at Union Seminary in Richmond, VA.

After graduating, I received a call to serve as the Director of Christian Education at First Presbyterian Church in Goldsboro, NC, where I worked for 11 years before moving to Gastonia, NC. It was at my first call where people recognized my gifts for ministry and encouraged me to seek ordination. My love for working in the church kept me busy, and I felt like the path to ordination was long and difficult, and I had no time for it. Years passed, and the yearning and desire to be ordained as a minister of word and sacrament kept burning alive in me. I finally realized that I had spent several years waiting to get started in the ordination process, and that if I wanted to pursue it, I would have to go through the entire MDiv program. The Holy Spirit's nudging was firm and strong, and with much prayer and preparation, I decided to enroll in the MDiv program and pursue ordination.

Doubt and fear were present, but the Spirit's encouragement and a supportive community continually affirmed my calling. These reminders strengthened my confidence to serve the church. For 14 years, I have served as a Christian Educator, and now I feel called to serve as a minister of Word and Sacrament.

Now, instead of waiting for dramatic signs, I pay attention to daily interactions, my participation in church, building relationships, and my learning in a community of faith. Through these experiences, I clearly hear God calling me to serve and care for God's people. God calls ordinary people and in ordinary ways, and each experience confirms my calling.

Faith & Sexuality Retreat

What to Expect

We understand that talking about sexuality with your middle school aged children can often be an intimidating and scary thought. Letting total strangers talk to your middle school aged children can be even scarier!! Let us put some of those fears to ease.

What should my child and I expect that day?

To be challenged by participating in discussions of what it means to be a Child of God who is created as a sexual being. We open the morning with get to know you activities and an opening session where parents and children are together. We then breakout into a parent session and youth session. Typically, youth are separated with 5th and 6th graders together and 7th and 8th so topics are developmentally appropriate. We provide lunch all together around noon, before entering separate afternoon sessions. At around 3, we come back together for some fun family time where youth will be able to share what they have learned and parents will be able to interact with their youth in a way they have not previously. To finish the day, we have a time for reflection and sending off.

What are you going to teach my child?

We discuss the biological and emotional aspects of sexuality in age-appropriate ways. Using scripture, we identify, reinforce, and discuss how we are each wonderfully and perfectly made in the eyes of God. Children are taught about healthy relationships and provided an environment where talking about sex and their bodies is acceptable and encouraged, as well as how to set and maintain healthy boundaries with partners, friends, and adults.

Why do I have to come with my child?

Talking with your child about sexuality can be very overwhelming and often parents choose not to talk to them at all. During parent sessions, they are taught about ways to talk to their child and normalizing these conversations to make it more comfortable for everyone.

One past parent offered this reflection on the retreat: “The presbytery's middle school sexuality retreat delivered on a major promise: it opened lines of communication about puberty and sexuality and faith with our kids in a way that assumed those topics are (1) GOOD to talk about and (2) rooted FIRST in our created-ness as children of God. We *laughed together as families*, which made talking about awkward things so much less awkward. An amazing and unexpected fringe benefit was sharing an experience with other parents who helped me feel like I'm on a fun journey rather than entering a dreaded phase. “

Can I bring a younger or older sibling along with us?

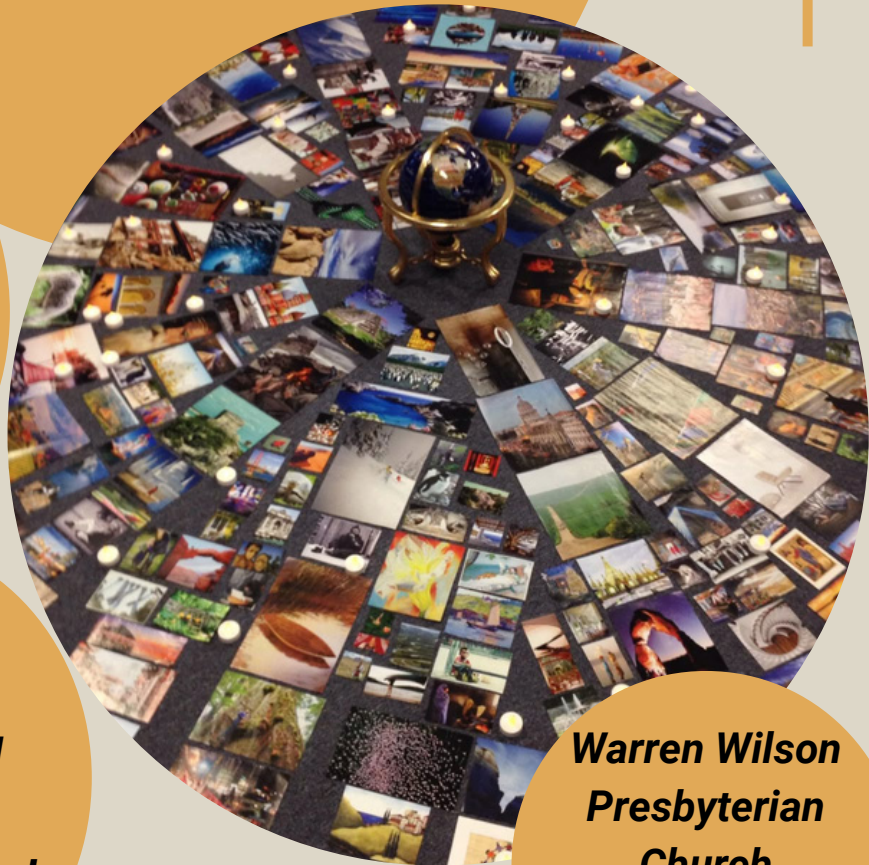

General Presbyter Report January 7, 2026

“What’s your relationship status?” Many of us have seen this question before on forms at the Doctor’s office, on a credit application, or as a part of the paperwork in applying for an open position. At first, I used to think this was an odd question to ask. I would often say “What does this question have to do with anything?”, thinking it is none of their business. Over time, my attitude and outlook have changed. Not only is this question informative for legal and medical purposes, I believe the meaning goes deeper. It means people want to know what are your connections. Who takes care of you in the time of trouble? Who can vouch for you? With whom do you share your life? What ways can we as a Presbytery strengthen our relationships and form new ones so people will know that we are connected as a body of Christ?

This year, my theme for the Presbytery of Western North Carolina (PWNC) will be *Building and Sustaining Relationships*. Called to be the people of God, we do not serve or worship in isolation of the community. I have learned two things about relationships: 1) they can always be strengthened, and 2) they are crucial to our identity and growth. As we move through 2026, I plan to focus my attention to building and sustaining relationship in the following ways:

- 1) **Welcoming new members into the Presbytery** – I will be working with Rev. Laurey Harrell, who serves on our Commission on Ministry, to develop a way in which new ministers are welcomed into the Presbytery. This will serve to familiarize new ministers to the life and work of the Presbytery, as well as helping them to form and build relationships with our presbyters.
- 2) **"What Is a Presbytery and Why Does It Matter?"** – I am in the process of developing a presentation with said title for congregations, sessions, and other interested groups to learn about the PWNC and why it matters. These will be in-person presentations given by yours truly. I hope to have more information about this coming soon.
- 3) **Presbytery Stewardship Team** – the Coordinating Ministry approved the formation of this team late last year. Its purpose will be to reach out to churches that have not contributed financially or participated in presbytery activities, focusing on education about presbytery functions rather than just soliciting funds.

In addition to these, I will continue to visit churches and pastoral leaders – which I really enjoy! I solicit your prayers as we carry out the theme for this year.

We continue to work on building and sustaining relationships in other ways. I hope you have heard by now the news of having our July Presbytery meeting in neighborhoods. Members of the Coordinating Ministry, in partnership with our Presbytery Associates, are working faithfully to make this a reality. The purpose of having these neighborhood Presbytery meetings is to form closer relationships with other

churches and become familiar with the work of the PWNC in a local context. I am looking forward to this!
