

Validated Ministry Team Handbook Presbytery of Western North Carolina

INTRODUCTION

Members of the Presbytery of Western North Carolina who are engaged in a Validated Ministry outside of a congregation shall maintain communication with the Validated Ministry Team.

According to the Book of Order G-2.0503a:

- "A validated ministry shall:
- 1) demonstrate conformity with the mission of God's people in the world as set forth in Holy Scripture, the *Book of Confessions*, and the *Book of Order* of this church;
- 2) serve and aid others, and enable the ministry of others;
- 3) Give evidence of theologically informed fidelity to God's Word;
- 4) be carried on in accountability for its character and conduct to the presbytery in addition to any organizations, agencies, and institutions served; and
- 5) include responsible participation in the deliberations, worship, and work of the presbytery and in the life of a congregation of a PCUSA church or a church in correspondence with the Presbyterian Church (U.S.A.) (G.5.0201).....

When ministers of the Word and Sacrament are called to validated ministry beyond the jurisdiction of the church, they shall give evidence of a quality of life that helps to share the ministry of the good news. They shall participate in a congregation, in their presbytery, and in ecumenical relationships and shall be

eligible for election to the higher councils of the church and to the boards and agencies of those councils.

The presbytery shall review annually the work of all ministers of the Word and Sacrament engaged in validated ministries outside the congregation."

The Validated Ministry Team considers and makes recommendations to the Commission on Ministry to validate or not validate such ministries.

This handbook provides a brief description of this process and a description of the criteria approved by the Presbytery for those seeking this type of validation.

Also included are the questions for annual review and the initial application forms for the minister and for the agency/organization.

All completed applications and any additional information should be sent to the current Chair of the Validated Ministry Team.

PROCESS FOR VALIDATION AND REVALIDATION OF MINISTRIES BEYOND THE CONGREGATION

Members of the Validated Ministry Team shall be appointed by the Commission on Ministry.

The team reviews all applications for new validated ministries face to face, (by Zoom or in person).

The team reviews validated ministries for renewal annually, and ministers have a face to face interview at least every three years.

Every validated ministry is assigned a liaison who facilitates the annual review process and reports to the Validated Ministry Team.

When the Team sees satisfactory evidence that the ministry meets the criteria for validation, it shall recommend validation or re-validation to the Commission on Ministry (COM).

When the Team identifies concerns, it shall invite either the minister, a member of the employing agency, or both, to respond.

If the Team decides not to recommend validation or revalidation of the ministry, the Team shall inform the minister, the employing agency, and the COM of this recommendation with a concise, written statement of its concerns and reasons.

Applicants, ministers, or agencies/organizations may appeal this decision to the COM.

CRITERIA FOR VALIDATING MINISTRIES

In determining which ministries shall be validated, the Validated Ministry Team shall be guided by these criteria:

- A. A validated ministry shall demonstrate conformity with the mission of God's people in the world as set forth in Holy Scripture, the *Book of Confessions* and the *Book of Order* of the Presbyterian Church (USA). [G-2.0503.a (1).]
- B. In particular, this ministry shall help the Presbytery fulfill its mission.

- 4. Where could improvements be made?
- 5. What do you wish we had asked but did not?
