## **Report of the Administrative Commission First Presbyterian Church of Marion, NC April 26, 2011**

On January 2, 2010, the congregation of First Presbyterian Church of Marion voted to change their Articles of Incorporation and Bylaws to bring them into compliance with the Constitution of the PCUSA. As of April 1, 2011, all necessary documents have been submitted to the North Carolina Secretary of State for approval. When approval is granted, the Administrative Commission will request to be dismissed at the earliest possible date by the Presbytery of Western North Carolina.

Again, we wish to express our sincere thanks to the Marion Session for all their hard work and to their interim pastor, the Rev. Dr. Dan Thornton, for his outstanding service to the congregation. We are most encouraged by the ordination and installation of Marion's new pastor, the Rev. Mr. Jeff Coffey, and will continue to pray for God's blessing upon the congregation in the days ahead.

## Report of the Administrative Commission

---

### Iglesia Emanuel, Hickory, NC

April 4, 2011

On Sunday, April 3<sup>rd</sup>, the seven covenant churches celebrated their relationship with Iglesia Emanuel with an evening service where we joined together in the Lord's Supper as well as signing the covenant for another year. There were about eighty people in attendance, from that congregation as well as the supporting congregations. Gary Van Brocklin preached in both English and Spanish, and Anita Bernhardt led the liturgy. We were accompanied by the Northminister choir and musicians.

At the conclusion of the service, the congregation sang one of their favorite hymns, *America Will Belong to Christ*, and there were fourteen different countries represented and waving their flag. This reminds us that we often forget how diverse the Hispanic cultures are, bound together only by the common language. The congregation at Iglesia Emanuel has seen that part of their ministry is bringing together the people of these different cultures into one faith community. On the top of their bulletin now, each week is the mission statement: *From many Cultures, United in Christ*.

We are very thankful for the leadership of Gary Van Brocklin as "stated supply." He is a professor at Montreat College, but he and his wife Marlene have experience as missionaries in Central and South America.

March was a very good month, with a high in worship attendance of 28, with 14 children and adolescences. Part of the good news is the return of former members and participants, some of whom have not been there for years and some others who left after Jorge resigned. We asked the leadership why they thought that happened, and they attributed it to "an American pastor." What they meant was someone who was not biased to one of the Hispanic countries and who was not facing immigration issues. This was an important insight as we continue to explore the future of this ministry.

They are continuing to explore some a partnership with the neighboring Presbyterian Churches for children's and youth ministry. Some of the children have attended the Wednesday program at First, Hickory; and some of the middle school the special activities at New Vision. They need someone to lead the education with the 6<sup>th</sup>-12<sup>th</sup> graders.

They have begun to contribute something each month towards the pastor's salary, as well as paying the insurance on the building. There is concern about a needed repair to the air conditioner, which had one estimate at \$800. We did point them to the small church grant from PWNC.

Gary Van Brockin's contract is up in June, but he has indicated that he is willing to sign another six month contract. We are using this time to explore the focus and needs in this ministry.

## Administrative Commission Report

### **New Vision Church Conover, North Carolina April 12, 2011**

The Administrative Commission/Steering Team for New Vision met on April 4, 2011.

We celebrate the ministry that continues to happen here:

- Two new families have covenanted with New Vision, and we will have a baptism on Easter Sunday.
- The Pack-a-Bag ministry continues to feed 80 students each weekend. We have applied for a Nickel a Meal grant to help some of the short fall this year.
- There is a new group for TWEENS (5-8 grades) that meets every week for study as well as for special events.
- There is work on a Wednesday night experience that would meet the needs of this congregation.
- Two members will be attending the Presbyterian Pilgrimage.
- We are partners with the Hickory Habitat Presbyterian House.
- We are planning a full Holy Week schedule, with a reading of the Passion on Palm Sunday, a Maundy Thursday Seder communion, involvement in the community Good Friday and Sunrise services, and a Easter Sunday Service, with brunch and Easter Egg Hunt.

We continue to seek ways to reach out to the de-churched and un-churched in our community. In May, the Pastors will go to training from LifeTree Café at the Group headquarters in Colorado. This is a creative way we see to reach out and involve people in the faith dialogue.

We continue to wrestle with the interconnected issues of growth and finances. We have sought all different ways to reach out to the community, some successful, some not so much. At this point, we find the most effective is personal invitation by those a part of the community, and God just sending people who “drive by.”

We feel that most of the people are giving faithfully. However the financial expectations from the mortgage on the building are beyond what we receive. We are grateful to the PWNC for continuing their support. We continue to seek creative ways to better use this facility.
