Personal Biography

Growing up in a nominally Christian home meant only an occasional faith connection until I entered high school. In high school my family began attending the local Presbyterian Church where I got involved in the church youth program. During the summer after my sophomore year in high school I went to senior high camp. From that experience on my life began to change. For the remainder of high school I was active in Presbytery youth activities, Synod youth events, and even the forerunner to Youth Triennium at Purdue University. A.T. Brown (Director of Camp Glenkirk) and his wife Doris took me under their wing and guided the formative years of my life in the faith.

Following high school I attended college, and while not being outwardly active in the church, I maintained my connection with the Brown's. During my college summers I served as a church camp counselor in various presbytery camps. Through God's guidance from Doris and A.T. and others I continued to struggle with my faith.

After college I spent a couple of years wrestling with God's direction for me in my life. Eventually I attended the Presbyterian School of Christian Education, got married to Judy, and began work as a Director of Christian Education. In the summer of 1974 I moved to the Blacksburg Presbyterian Church as the church's DCE.

But God had other plans for me. A month after moving to Blacksburg the church's minister died unexpectedly. My role as D.C.E., while the same on paper, changed. I did a great deal of the church's administrative work, and at this point really began to wrestle with whether God's was calling me into the ministry.

God was calling me, and I responded to that call. First, I did the D. Min. intern year (when the D. Min. was an in-sequence four year program), while still working as a D.C.E., and then went to Union Theological Seminary for two years. The years at Union confirmed over and over again that God had plans for me. While there my wife and I had/received our first child, Daniel (adopted).

After seminary God called me to a small church in southeastern North Carolina, where I was fortunate to be with several classmates. Having classmates in ministry helped me get started, continue to grow as a pastor, and mature in faith. At the end of this pastorate Judy and I had our second child, Rebecca.

My second church, at the beach, continued my development as a pastor in the work God was calling me to do. During my beach ministry the church grew, built a new sanctuary, and acquired land to secure the church's future needs.

Eventually I got called to Gastonia, NC, to serve, and where my wife, Judy, wrestled with God's call for her. I continued at the church and Judy went off to seminary. It was a struggle, but with God's support through this Presbytery we succeeded.

Following Judy's graduation from Union Theological Seminary we received calls to the mountains of West Virginia. We served all of the Presbyterian church in one county (Judy had two churches and two chapels, and I had three churches).

Eventually we moved to Virginia. I took a small church, which proved to be a bad fit. After a little over two years God called me to what became my final church before retirement. The fit was good, and we had a wonderful ministry together.

In my life's journey I can look back and truly say that God was leading me. I am continually humbled by the way God has worked and continues to work in my life.

Statement of Faith Brian D. Weger

I believe in one God; Father, Son, and Holy Spirit. So, for me, the Godhead is composed of three persons, but who are of one substance, power and eternity. Or, as "The Westminster Confession of Faith" puts it so succinctly for me; there is God the Father, God the Son, and God the Holy Ghost. I trust in the one living God, and that God alone I worship and serve, paraphrasing the "Brief Statement of Faith".

I believe in God the creator. God created the world and declared it good. God made man and woman in God's image; male and female God created them. And, the God who created is also the God who is sovereign. God has dominion over everything. But, humankind has rebelled against God, even from the beginning, as with Adam and Eve; and, of course, the turning away from God continues even today. Yet, God has been and continues to be faithful; loving humanity despite it's sinfulness. God's love comes across most powerfully in the sending of Jesus Christ, his only Son.

I believe in Jesus Christ, the love of God made manifest in world. Only through the life, death, and resurrection of Christ Jesus can we begin to grasp the love that God has for us. Or, as the Apostle Paul tells us so eloquently in Romans 8, "nothing can separate us from the love of God, which is in Christ Jesus our Lord." God's love in Jesus Christ offers us salvation, forgiveness, redemption, and new life. Therefore, God's love for us doesn't end with Jesus' crucifixion and death.

I believe in the Holy Spirit, God's abiding presence with us in the world. The Spirit brings God into our lives, in very real and concrete ways. We experience God's power through the Spirit working in us and others. The Spirit provides the way for God to continue to be with us, no matter what our circumstances are.

I believe God gives us his/her living Word in the Scriptures of the Old and New Testaments. The Bible is the very ground of faith and practice for me. The Scriptures guide me in the ways of the living God, even though I know that human flaws have marred and continue to mar faithful interpretation. Still, I believe that the Reformed tradition offers the best way for faithful interpretation, guided by the leading of the Holy Spirit.

I believe the church is the very expression of God's work in the world. And, the words of the theologian Hans Kung address for me the very substance of God's church; the people of God, the creation of the Spirit, and the body of Christ. Moreover, the church that best lives out Kung's description of the church for me is the Presbyterian Church (U.S.A.). The Presbyterian Church is home for me, always has been and always will be.

I believe in the Sacraments of the Presbyterian Church; Baptism and the Lord's Supper. In the water of baptism we are in-grafted into the family of God; we become children of God. And infant baptism attests that God claims us, even before we are able to respond. In the Lord's Supper we experience Christ's sacrifice for us. Through the bread and the wine we are reminded in a visceral way of what Christ was willing to do for us sinners. The sacrament truly expresses the magnitude of God's love for us.

Finally, I believe in the Presbyterian Church (U.S.A.) as the manifestation of Christ's body in my life. I love the church, despite its flaws and foible's, as well as for it's compassion, openness, and love.

COM ATTACHMENT 9

Faith Journey: Judith H. Weger

Having been raised in a United Methodist parsonage, I entered adulthood with a pretty strong belief in our triune God. After all, I'd been nurtured at home, at church, at camps, and at work camps. But I was also and introvert who had moved every 3 or 4 moves. Since the role models were all men in ministry, I came to adulthood determined I'd never marry a minister (and I didn't! Brian went to seminary after we were married and I worked to help put him through school.)

Children began coming at the end of Brian's seminary. I was pleased to be able to stay home with the children while they were small; but as they entered school, I felt the need to begin to enter the work force again. Having had some experience in library science, I applied to set up and run the resource center at Gastonia for the Presbytery of Western North Carolina. But two resource centers was a luxury that could not be afforded. As my contract ended, I helped to move the Resource Center to its current location as I struggled with what God wanted me to do next.

At the time Brian graduated from seminary, clergy couples were just beginning to be seen. Brian had made a negative comment about his view of what he was seeing, and I had remembered it over the years. A call to be a DCE seemed a possibility, but not a call to ministry of Word and Sacrament. One thing I knew; I didn't feel God wanted me in the secular work force at this time. Just before we headed to Montreat for continuing education, Brian asked if I had considered preparing to enter the ministry. This opened a new possibility for me to consider. At Montreat the Blue Presbyterian Hymnal was being introduced. One of the hymns being sung on a daily basis was "Here I Am, Lord". Try to turn down a call to God in that atmosphere! I headed to what is now Union Presbyterian Seminary under the care of and with the financial help of the Presbytery of Western N.C. (Thank You)

In my last year of seminary, I did a winter term in Southern Appalachia. As we traveled the back roads of NC, TN, and VA, I felt that my call was to the small churches of Appalachia. After ordination, we moved to Pendleton County, WV, where I served two small churches and two chapels for half time pay. I quickly realized that seminary does not fully prepare a minister for small church ministry. I was fortunate to be a part of a DMin program with a small church emphasis at Pittsburg Seminary.

Before finishing my doctorate, having two children in college financially required us to have two full time calls. I answered a call to Peace Presbyterian Church in Roanoke, VA, where I completed my doctorate as we struggled with what their mission was to be and built their first permanent structures. While this was a very fulfilling pastorate in many ways, it was also physically demanding. After 8 years I was feeling a lack of sufficient energy to help them with their next stage of growth. And so I went to Glasgow Presbyterian Church and served as their stated supply for the last three years of my active ministry. I feel blessed to be able to retire to Spruce Pine, and once again enjoy being in the Presbytery of Western Carolina.

COM ATTACHMENT 9

Faith Statement: Judith H. Weger

I believe in one God, present from before the beginning of time, who ultimately rules the universe. God has chosen to be made known to humans in three ways:

- God the creator and sustainer of the world has reached out to humans from the beginning. But humans were not able to constantly remain in God's presence. We sinned and wandered away. God reaches out to us. The Old Testament tells of God repeatedly sending prophets to draw us back into the fold. In Christ, we have learned to call this part of the trinity Abba, Father.
- Jesus, the son, is God with us. In Jesus, God has taken human form, fully God. In the life, teachings, crucifixion, and resurrection of Jesus we see the full nature of God's love. Jesus died on the cross and rose, becoming Savior of all who believe in Him.
- The Holy Spirit is God in us. The Spirit helps us to hear God's Word for us in Scriptures, to see God's hand working in our lives, to feel God's presence with us, especially in difficult times.

I believe that the Bible tells us the story of God working in and through humans who were created in God's image. In the Scriptures we see the imperfect workings of the created and the perfect Word of the Creator. With the guidance of the Holy Spirit, the Scriptures become a living Word and are the most authoritative source of God's Word for my life.

I believe that the church is God's body of believers in the World. Particular churches (local churches) are only a part of the body. When all parts are working together under the leadership of Jesus Christ, the head of the body, God's work is done in the world. While God does speak to us as individuals, I believe that God's direction for the church is most fully seen through the councils of believers. I believe God works through both laity and ministers of the Word, making the Presbyterian form of government the place I choose to be a part of God's body.

I believe that in Christ's life and teachings we have been given our two most sacred rituals, our sacraments. Through these sacraments God continues to reach out to humankind today.

- In baptism we are accepted into the body of Christ. While we may be baptized at any stage of our lives, infant baptism reminds us that we are welcomed into God's family not because of what we can think or do, but because God has reached out to us in love. Even as adults, our part is only reaching back and accepting what God gives to us.
- Holy Communion continues to nurture us in the life of faith. Christ fed his followers through his teachings, their fellowship meals, and in Jesus giving his body and blood on the cross. In the same manner we continue to be nurtured in the life of faith as we gather together to hear God's Word, eat at God's table, and receive the body and blood of the one who died and rose again that we might have life everlasting.

Synod of the Mid-Atlantic Summary Digest of the 228th Stated Assembly Meeting

The 228th Stated Meeting of the Synod of the Mid-Atlantic was held at Ginter Park Presbyterian Church in Richmond, Virginia on September 26 & 27, 2011. The following is a summary digest of its actions and decisions.

ADMINISTRATION AND PERSONNEL

<u>Personnel</u> – In light of impending changes in staffing due to a retirement, and to the completion and/or discontinuation of certain long-range staff functions, the synod authorized the elimination of the position of Office Manager and the position of Archivist and Special Projects Manager. The creation of a new part-time (30 hours per week) position of Synod Administrator was approved. The new position has been advertised; more than fifty resumes have been received and winnowed down to a group of six to be interviewed on September 29th. (*NOTE: A new person was hired for this position, and is to begin in mid-October*).

<u>Review of Presbytery Minutes</u> – The first year of a new procedure for reviewing Presbytery Minutes is nearing completion, and will be reassessed after an initial two-year trial.

<u>Sale of Office Building</u> – The Administration Committee continues to work with the Synod Executive on the sale of the office building at 3218 Chamberlayne Avenue.

<u>Dates for 2012 Synod meetings</u> – The following dates have been set for the Synod's 2012 Stated Meetings, pending confirmation of housing availability at Union Seminary: March 19-20 and September 18-19.

FINANCE

Repurposing of Funds – Upon recommendation from the Finance Committee, some of the Synod's investment funds have been repurposed in order to put the funding for the Synod's operational costs on a more stable and sustainable basis, and also to lessen the percapita impact on our presbyteries. This action came in response to a meeting of several presbytery and synod leaders held in August. The changes include renaming of the Emergent Ministries Fund as the Synod Governance Fund. Other measures to combine and enhance funds in support of mission initiatives will be developed by the Grants & Awards and Presbytery Initiatives Committees.

<u>Baltimore Presbytery Redesignation</u> – In order to assist with the percapita situation, Baltimore Presbytery acted to redesignate its shared ministry contribution to be applied toward the overall operating expenses of synod, with attendant adjustments to the percapita askings of all Mid-Atlantic presbyteries. The net result is a reduction of \$.05 in the percapita rate for 2012. 2012 Budget and Percapita Askings – The Synod Assembly adopted a governance operating budget of \$306,715 for 2012, with the following implications:

- That the per capita rate for 2012 preliminarily set at \$.85 be reduced by \$.05, thus resulting in a 2012 per capita rate of \$.80.
- That the newly repurposed "governance fund" be used to balance any 2012 budget shortfall – presently estimated at \$60,000.

<u>Funds Administration Costs</u> – Upon recommendation by the Finance Committee, the Synod Assembly took action to allocate the costs of administering the synod investment funds to those funds, to the extent allowed by the donors of restricted funds. That cost is estimated at \$30,000 for 2012.

ADDENDUM II

PRESBYTERY INITIATIVES

<u>Change in maximum Grant Amount</u> – Synod acted to change the usual grant amount from a maximum of \$2,500 to a range of \$2,500 to \$10,000, depending upon the funds available and the needs of the initiative request.

Grants Approved – Synod approved the following Initiative grants:

- \$2,500 for the 2012 Synod Presbyterian Men's Conference (National Capital and Shenandoah).
- Synod Presbyterian Men's outreach trip to Kenya, for \$5,500 total: \$1,500 for chapel furnishings and \$4,000 designated for scholarships, with no more than \$1,000 going to any one presbytery (Shenandoah and Peaks).
- \$5,000 for the 2012 Multicultural Conference (Charlotte and Salem).

GRANTS & AWARDS

New and Small Church Grant Fund – Synod approved the following grants from this fund:

- \$2,500 to Stanley White Presbyterian Church, Roanoke Rapids, NC, for a capital improvement project, pending New Hope Presbytery approval.
- \$2,500 to repair major storm damage at the Dickey Memorial Presbyterian Church, Baltimore, MD, pending Baltimore Presbytery's approval
- Two grants in the amount of \$2,500 each to Canton Presbyterian Church and \$2,500 to Marshall Presbyterian Church, in support of the GA program "Such a Time as This" aimed at transformation of small churches with potential for growth.

<u>Visionary Fund</u> – Synod approved the following grants from this fund:

- 2,500 to the Presbytery of Western North Carolina for a one day Christian Education training event, subject to the grantee affirming the racially inclusive nature of this event.
- \$1,200 to the Resource Center for paying the Synod's annual Resource Center Subscription Fee (\$600/year) for 2011 and 2012.

<u>Peacemaking Fund</u> – \$2,500 to the Presbytery of Western North Carolina to hold a 2-3 day "Conflict/Mediation in the Church" training event for Committee on Ministry members and Presbytery staff.

<u>200th Anniversary of Union Seminary</u> – Authority was given to the Executive Committee and Grants/Awards Committee jointly to consider the request for scholarship funding for Union Presbyterian Seminary in honor of its 200th anniversary.

Moderator Sylvester Bullock (James) read the names of, and offered an expression of gratitude to, the following commissioners who are completing their terms of service: Barton Bacon (PEVA); Miriam Dewhurst (National Capital); John Gilmore (New Castle); Michael Hickman (Peaks); Bumsoo Kim (AKAP); Bill Parish (Abingdon); Jim Schroll (Baltimore); Becky Stanley (WNC); and George Wilson (Coastal Carolina).

Also completing terms of service are: Bill Staples as Treasurer, and Barbara Willis and Jeff Porter as advisory members of the Finance Committee).

PRESENTATION ON "BECOMING THE BELOVED COMMUNITY"
