# John H. "Jack" Haberer, Jr. Editor for

### The Presbyterian Outlook

Born in New York City, Jack was raised in the New Jersey suburb town of Ramsey. A Roman Catholic in training, Jack professed his Christian faith at age 15 by way of the Jesus Movement. Along with two friends, he organized a coffeehouse, which grew almost immediately to an average attendance of 200 on a typical Saturday evening.

He earned a B.A. (magna cum laude) in religion & philosophy from Roberts Wesleyan College in Rochester, N.Y., married Barbara

Niswander and returned to his hometown to work in a religious bookstore. While there he spearheaded the formation of a non-denominational church.

He then earned the M.Div. degree from Gordon-Conwell Theological Seminary in Massachusetts, and upon graduation, joined the staff of New Covenant Presbyterian Church in Pompano Beach, Fla. Two years later he was ordained as minister of word and sacrament and called to pastor Trinity Presbyterian Church in Satellite Beach, Fla., where he served 10 years. While there he earned the D.Min. degree at Columbia Theological Seminary in Decatur, Ga. His doctoral dissertation was titled, *The Presence of the Spirit: Elusive or Abiding ...Toward a Theology of Spirituality*. He also chaired two committees for Central Florida Presbytery.

In January, 1994, Jack was called to Clear Lake Presbyterian Church in Houston, Tx., where he served as pastor, head-of-staff, for 12 years. While there he served as chair of the board for two national organizations, The Presbyterian Coalition and, later, Presbyterians for Renewal. He authored two books (both published by Geneva Press): *GodViews: The Convictions that Drive Us and Divide Us* and *Living the Presence of the Spirit*.

Widely recognized for his skills in bridge-building and bringing reconciliation he has been appointed to three denominational task forces: The Unity-and-Diversity Conference Planning Committee; the Task Force on the Peace, Unity and Purity of the Church; and the Washington Office Study Task Force. He is a much-sought-after speaker for major conferences.

In January, 2006, Jack was called to serve as Editor-in-chief and Publisher of *The Presbyterian Outlook*, an independent, national, weekly magazine serving the leadership of the Presbyterian Church (U.S.A.). Long known as the "thought leader" of the denomination, the *Outlook* has been published for 65 years in Richmond, Virginia, and is an outgrowth of other publications that date back to 1818.

Jack and wife Barbara are parents of two adult children, David and Kelly, and have three grandchildren.

#### **NEWCOMER'S GUIDE TO PRESBYTERY MEETINGS**

#### **WELCOME!**

Despite rumors to the contrary, many really do enjoy the time of fellowship and sharing when our Presbytery meets. However, if you have not been to such a meeting before, it may seem a little confusing at first. It is hoped that this guide will make your participation more meaningful. For at Presbytery meetings, we have good news to share, successes to celebrate, helpful resources to publicize, important (and some not so important) decisions to make, plans to approve, and a wonderful family of 112 congregations to get to know better.

#### WHAT IS A PRESBYTERY?

A Presbytery is the key governing body in our denomination. There are 173 Presbyteries in the Presbyterian Church (USA). Ours includes all the PCUSA congregations with nearly 19,000 members in 23 counties in the western part of North Carolina. It consists of all the active Ministers and at least one Elder from each congregation (larger ones have additional Elders). Various procedures ensure that there is approximately an equal number of Ministers and Elders; both are known as commissioners and they have an equal vote. It is vital that each congregation be represented by its Elder(s)!

#### WHAT DOES A PRESBYTERY DO?

A Presbytery is responsible for the mission and government of the Church throughout its area. "In partnership with Sessions, the mission of our Presbytery is to foster vital and faithful congregations to be effective witnesses for Jesus Christ." By combining resources, Presbytery can help each church improve its ministry by assisting with the calling of pastors, teacher training, grants and loans, officer development, camping, mission trips, and many other support services.

#### WHEN DOES PRESBYTERY MEET?

There are four full-day stated (regular) meetings, generally towards the end of the months of January (Saturday), April (Tuesday at the Montreat Conference Center), July (Tuesday), and October (Friday and Saturday at the Lake Junaluska Conference Center). Special meetings at other times can be called, and Presbytery committees meet throughout the year.

#### WHAT WILL HAPPEN AT THIS MEETING?

All commissioners will receive, in advance, a packet of reports, proposed actions and background information. Other papers (generally called "Addenda") will be handed out when you register. Please read these carefully, and be prepared, since these papers will only be referred to during the meeting before a committee chair (with some explanation) moves adoption of an action.

In general, these things will occur:

- 1. <u>Celebration</u>: We will worship together with hymns, prayers, Scripture, preaching and the Lord's Supper. We will also welcome new ministers, commission teams on mission trips (especially to Guatemala and Malawi), give thanks for special achievements, and pledge ourselves to better mission and witness. Join in the fellowship of committed Christians.
- 2. <u>Information</u>: You will learn about lots of events and opportunities to share with your Session and congregation: new programs, mission plans, available resources, etc. Be a good communicator when you are back home.

- 3. <u>Education</u>: You will hear from missionaries, as well as leaders of our colleges, children's homes, camps and other institutions; Presbytery officials and Ministers joining our Presbytery. There is always much to learn.
- 4. <u>Presbytery Procedures</u>: Much is fairly routine: adoption of the docket (order of consideration), approval of minutes, receiving reports, etc. Several routine housekeeping matters are put together in an Omnibus Motion, which is voted on as a unit (but you can remove any item for later discussion). Though rather unexciting, these matters are necessary.
- 5. <u>Debate and Action</u>: At most meetings, there will be a few items that deserve extensive discussion. Though each recommendation has been reviewed by a committee or the Coordinating Council, it should nevertheless be carefully considered before you decide how to vote. If you do not understand what is happening, please ask the Moderator to explain the matter currently before the Presbytery. If you want to offer a motion, the Stated Clerk would be glad to help you draft it. Don't worry about parliamentary procedure. Your role is to listen carefully, share in the debate, if you feel led to do so, and then vote as the Holy Spirit leads you to understand what is best for Christ's Church.

It is a privilege and responsibility to help guide this part of the Church of Jesus Christ. *Be prepared. Listen. Pray. Take notes. Report back home.* Remember that you are helping our Presbytery in a much valued and vital way to build up the Body of Christ, to the greater glory of our Lord.

#### RULES FOR DEBATE

- 1. When any commissioner wishes to speak (other than to second a motion, which can be done from one's chair), he or she shall go to one of the floor microphones and seek recognition from the Moderator.
- 2. When recognized, the commissioner shall state his or her name and position in Presbytery before contributing to the debate.
- 3. All remarks should be addressed to the Moderator, should be confined to the merits of the pending question, and must not attack a commissioner's motives.
- 4. If several commissioners are standing at microphones waiting to speak to the same motion, the Moderator shall attempt to alternate pro and con speakers.
- 5. All proposed amendments (other than a few consecutive words) <u>must</u> be submitted in writing to the Stated Clerk, preferably in advance of making a motion.
- 6. If time for further study or consultation is desired before a vote is taken, commissioners shall ordinarily offer the motion to Postpone to a Particular Time, instead of a motion to Lay on the Table.
- 7. If a commissioner wishes to end an ongoing debate,
  - a. he or she must go to a floor microphone and obtain recognition from the Moderator;
  - b. when recognized, he or she may move the previous question;
  - c. another commissioner must second this motion (can be done from one's chair, without recognition);
  - d. the Moderator shall immediately conduct a standing vote on this motion to cut off further debate; [Note: The above is *Robert's Rules* as is enjoined by our constitution (*Book of Order, G-3.0105*). However, this Presbytery chooses to follow the Parliamentary Procedures of the General Assembly, which give the Moderator some discretion in this matter. "The Moderator is in a position to refuse premature closure of debate by a member through the use of the motion to 'call the question.' If, in the Moderator's judgement, the assembly has not completed debate, the Moderator has the power to refuse the motion to close debate."]
  - e. if there is a two-thirds affirmative vote to end debate, the Moderator shall immediately conduct a vote on the motion before the Presbytery.
- 8. The substitute motion is a form of amendment applied when the desire is to amend a motion in several different, nonconsecutive places. It also is used when the text to be amended is longer than a paragraph. The following procedure may be used (at the Moderator's discretion) after a substitute motion is made.
  - a. The Moderator calls for perfecting (improving) amendments to the main motion. The amendments may be debated. Nothing else is in order.
  - b. The Moderator calls for perfecting (improving) amendments to the substitute motion. The amendments may be debated. Nothing else is in order.
  - c. The Moderator puts the question: "Shall the substitute motion replace the main motion?" At this time, the merits of both the main motion and the substitute motion may be debated, but no further amendments are in order.
  - d. The Moderator takes vote on the above question.
    - 1. If the question is approved, the main motion disappears and the substitute motion is before the assembly for further debate and vote.
    - 2. If the question is defeated, the substitute motion disappears and the main motion is before the assembly for further debate and vote.



- 9. THAT the 2010 Minutes of the Presbytery of Western North Carolina were reviewed by Stated Clerks of the Synod of the Mid-Atlantic in Boone, NC on June 18, 2011. The minutes were read to insure complete and accurate records of those meetings. The 2010 minutes of the Presbytery of Western North Carolina were approved as submitted.

### STATED CLERK ATTACHMENT 1

#### Report to Presbytery of Western North Carolina Steering Team for Iglesia Emanuel August 28, 2011

The Steering Team met on August 28, 2011 at the church.

Over the past months, the congregation and the Pastor have been having an extremely constructive dialogue about what their future could look like. They are discussing joining with another congregation to help build a "mosaic congregation." This would bring together their gifts and strengths with an established church, meeting their needs for nurture for their children and youth.

For the first part of the meeting, we met with a significant part of the congregation. They expressed their appreciation for all the Emanuel had meant to them and the ministry that it had; they shared their fears of changes that might come in any future; and yet they affirmed they realized that a mosaic congregation was a healthier future for them. There were a couple of members not in attendance. Gary shared that two of them are opposed to any changes, and one significant leader was having some tension with others.

In the next part of the meeting, the Steering Team met with Gary VanBrocklin, their pastor. We affirmed the work that Gary has done in this congregation. They are healthier and more energized than any time in the recent future, much to be owed to his leadership. And he feels that this is just the time to help these changes alone. He also agreed to negotiate a contract to continue through the transition time, on a reduced schedule. The chair and associate presbyter will negotiate this at a later time, however he felt that this assurance would ease some of the fears of the people.

We reviewed the reason for this transition. Some of it is the simple financial and facilities question. The building, owned by the Presbytery, is old and will continue to need upkeep that the congregation cannot afford alone. Although the location is central to the current membership, it is not in a conducive location for outreach. There has been a continuing need for a children's and youth ministry that is more reflection of the Anglo world they live in. We also acknowledged the challenge of finding trained pastoral leadership for this congregation.

But beyond even that, there is the theological question of the greater unity of the church of Jesus Christ. Can we make a more powerful statement to the world as a "mosaic congregation" than as two separate congregations?

Some research into the successful Hispanic NCD's have shown that most are "nested" in some form or the other in another congregation, and that most of the failures have been the independent ones. There are a variety of models, from two congregations using one building, to one service with translation and a unified and representative Session. The Presbytery of Atlanta seems to have been successful in bringing together Anglo and Latino congregations.

The Steering Team and the congregation know there is a lot more to do if this vision will become a reality. We will begin a dialogue with two neighboring congregations who have been open to the idea. We covet your prayers as this brave people continue to move out in faith and trust.

### STATED CLERK ATTACHMENT 2

#### Report to Presbytery of Western North Carolina New Vision Presbyterian Church September 2011

It was a good summer at New Vision. We have had a slow but continual growth of new people coming, and becoming part of the ministry. We had a Covenant Class in August, and there were six new covenant members, and we have about a dozen more who probably will be taking the class in October.

We had a great Vacation Bible School, with a consistent forty-five kids and almost forty youth and adults who helped out. A dozen were under five years old. There were between ten and twenty adults in the Adult Café each week. We had a new playground up for VBS.

We have begun a new outreach ministry of LifeTree Café. Part of the commitment was to create a welcoming café space in our fellowship hall. We repainted and put in four person café tables, as well as a flat screen TV and sound system. We launched the LifeTree Café the second week in August. We have had over twenty people every week as we consider the issues of life and faith. LifeTree Café helps people to learn to think theologically and not dogmatically about issues we face in our everyday life.

With the departure of Mark Watson, Greg Smith (First, Hickory) was nominated and approved as chair of the Steering Team. We also added Ryan Brakemyer from Northminister in Hickory.

We are in dialogue with Iglesia Emanuel about what their future might look like, and the possibility of creating a "mosaic congregation."

We continue to struggle with finances. Many of our members are struggling on their own finances, and give as faithfully as is possible.

Other happenings at New Vision:

- Two of our members have applied for the School of the Laity program.
- One of our new covenant members is a college student at Montreat College who is interested in becoming an Inquirer.
- We have opened our building for an ecumenical men's Bible Study on Monday nights.
- The Pumpkins will arrive on Sunday, October 2. We feel this is as much an outreach as fund raiser.
- We will begin our fourth year providing weekend food for Shuford Elementary School. In August, New Vision Church was recognized by the Newton-Conover School Board for their contribution to the school system. We received a grant from the Nickel a Meal program that helped us end last year in the black.
- In August, the Pastors attended the PCUSA NCD Conference in St. Petersburg Beach, FL. This was a time to make contacts with the national staff as well as get ideas of how other Presbyterian NCDs are working.

# COORDINATING COUNCIL ATTACHMENT 1

### STANDING RULES OF THE PRESBYTERY OF WESTERN NORTH CAROLINA

#### I. PRESBYTERY

- A. Name. The Presbytery shall be known as the Presbytery of Western North Carolina.
- B. Constitution. The Presbytery shall always operate in compliance with the provisions of the Constitution (*Book of Confessions* and *Book of Order*) of the Presbyterian Church (USA). It shall have the right to adopt Standing Rules (as a manual of administrative operations/bylaws) that are in harmony with that Constitution.
- C. Relationship to Higher Governing Bodies. The Presbytery is subject to the Synod of the Mid-Atlantic and the General Assembly of the Presbyterian Church (USA), as provided in the Constitution of the Presbyterian Church (USA).
- D. Geographical Area. The geographical jurisdiction of the Presbytery includes the 23 counties of: Avery, Buncombe, Burke, Caldwell, Catawba, Cherokee, Clay, Cleveland, Gaston, Graham, Haywood, Henderson, Jackson, Lincoln, Macon, Madison, McDowell, Mitchell, Polk, Rutherford, Swain, Transylvania, and Yancey. The Presbytery may be divided into clusters, which may serve as units for pastoral care, training, worship, and other useful purposes.
- E. Incorporation. The Presbytery of Western North Carolina is incorporated as a not-for-profit corporation according to the laws of the State of North Carolina. The Presbytery of Western North Carolina and the Presbytery of Western North Carolina Corporation shall meet at the same time and place, and in the announcement of the meeting, "Presbytery of Western North Carolina" shall designate both its functions.
- F. Members. All enrolled teaching elders (also known as Ministers of Word and Sacrament), as certified by the Stated Clerk, shall be members of the Presbytery.

#### II. OFFICERS OF PRESBYTERY

- A. The Officers of the Presbytery shall be the Moderator, Vice-Moderator (Moderator-elect), Stated Clerk, and Treasurer.
- B. Moderator's Election and Term. Each year at the third stated meeting of Presbytery, the Administrative Board of Presbytery shall present a nomination for Vice-Moderator (Moderator-elect). The name of the nominee will be announced in the docket packet mailed/e-mailed prior to the meeting and will be placed in nomination at the meeting. The Vice-Moderator (Moderator-elect) shall take office on January 1 following his or her election. On the next January 1, the Vice-Moderator shall become the Moderator being formally recognized at the next stated meeting of the Presbytery. The Moderator shall serve

in that office for one year, or until his/her successor takes office.

- C. Moderator's Duties. The Moderator shall preside at all meetings of Presbytery and perform all the duties prescribed in the *Book of Order*.
- D. Vice-Moderator's Duties. The Vice-Moderator (Moderator-elect) shall carry out the Moderator's duties when so requested by the Moderator, or when deemed necessary by the Administrative Board.
- E. Stated Clerk's Duties. The Stated Clerk shall be elected by the Presbytery and serve the Presbytery as its constitutional officer. The Stated Clerk shall perform those duties and functions prescribed in the *Book of Order* and those agreed upon by the Administrative Board. He or she shall annually arrange for the records of all Sessions to be reviewed. Subject to the approval of the Administrative Board, the Stated Clerk may appoint an Assistant Stated Clerk, whose term of service shall be the same as the Stated Clerk's. Should an investigating committee be necessary, the Stated Clerk and the chairs of the Administrative Board and the Support Division shall together appoint one, following the "Rules of Discipline" in the *Book of Order*. The Stated Clerk shall be elected for a term set by Presbytery, and is eligible to be re-elected.
- F. Treasurer's Duties. The Treasurer shall be elected by Presbytery and have oversight of the finances of Presbytery and is responsible for ensuring that the financial policies and procedures are followed. The Treasurer shall receive and disburse the funds of Presbytery as authorized, keep detailed account of all receipts and disbursements and report them to the Administrative Board at each of its meetings and to Presbytery annually, and work with any financial campaign approved by Presbytery. The Treasurer shall be elected for a term set by Presbytery, and is eligible to be re-elected.

#### III. MEETINGS OF PRESBYTERY

- A. Stated Meetings. The Presbytery of Western North Carolina shall hold four stated meetings each year, some of which may be a part of celebrative events. The time and place shall be set by the Administrative Board. In the scheduling of meetings, consideration shall be given to varied geographical locations throughout Presbytery and to work patterns of participants in the meetings.
- B. Special Meetings. The Moderator may call a special meeting at the request, or with the concurrence, of three teaching elders and three ruling elders, all elders being of different churches. Should the Moderator be unable or unwilling to act, the Stated Clerk may, under the same conditions, issue the call. If both Moderator and Stated Clerk are unable or unwilling to act, any five teaching elders and five ruling elders, all elders being of different churches, may call a special meeting. The synod may direct the Presbytery to convene a special meeting for the transaction of designated business. The notice of a special meeting shall be sent not less than ten days in advance to each teaching elder and to the session of every church. The notice shall set out the purpose of the meeting, and no other business than that listed in the notice shall be transacted.
- C. Meetings and Invitations. Invitations to host meetings shall be received and acted on by the Administrative Board.

- D. Docket. The Moderator and the Stated Clerk, in consultation with the General Presbyter, shall together prepare the proposed docket for each meeting of Presbytery, which shall be approved by the Administrative Board. Copies of the proposed docket shall be sent electronically or be mailed to all teaching elders, clerks of sessions, and others as requested at least ten days before each meeting. There shall be a worship service during each meeting that shall include the celebration of the Sacrament of the Lord's Supper. If circumstances permit, the pastor and session of the host church shall participate in this worship service. Memorials for church professionals and ruling elders who have died in the preceding twelve months shall be included in the worship service of one stated meeting each year.
- E. In order to ensure fairness and access to all necessary information, any new business to be dealt with at a Presbytery meeting, not arising from a Presbytery committee, shall be submitted to the Stated Clerk for inclusion in the packet no later than thirty days before the scheduled meeting of Presbytery. By a two-thirds affirmative vote, however, Presbytery may decide to consider other new urgent business, if brought to the Stated Clerk before 10:00 a.m. at the beginning of the Presbytery meeting. This new business shall be referred to the Bills and Overtures Committee for report later in that meeting.
- F. There shall be no distribution of materials at Presbytery meetings without prior approval from the Administrative Board.
- G. Rules of Procedure. The rules that shall govern all the transaction of business in all meetings of Presbytery shall be in accordance with the Constitution of the Presbyterian Church (USA), these Standing Rules (bylaws), and the most recent edition of Roberts Rules of Order, Newly Revised.
- H. Attendance and Voting. Each teaching elder shall attend each meeting of Presbytery, and each congregation shall be represented by at least one ruling elder at each meeting. Congregations are entitled to ruling elder commissioners based on the following active membership (BO: G-1.0402), as shown on the most recent statistical report:

251 - 750 members - 2
751 - 1250 members - 3
1251 - 1750 members - 4
```

Honorably retired teaching elders shall be welcome at all meetings, but their necessary non-attendance shall be excused.

To ensure approximate parity in numbers between ruling elder and teaching elder commissioners:

- 1. All members of the Administrative Board shall have voice and vote (if ruling elders).
- 2. All division, committee and sub-committee chairs shall have voice and vote (if ruling elders.
- 3. All Commissioned Lay Pastors shall have voice and vote.
- 4. All Certified Christian Educators, Certified Associate Christian Educators, and, in addition, other Christian Educators who have
  - earned at least a bachelor's degree (or its equivalent)
  - served in one or more educational ministries under the jurisdiction of a Presbytery (or one of its Sessions) for a minimum of two (2) years,

and

• been examined and recommended to Presbytery by the Christian Education Committee

shall have voice and (if ruling elders) vote, provided that these privileges shall end, pursuant to BO: G-2.1103, when such persons are no longer serving in an educational ministry under the jurisdiction of the Presbytery (or one of its Sessions).

- 5. All ruling elder commissioners to the Synod Assembly and to the General Assembly shall have voice and vote as long as their terms last.
- 6. All exempt staff of Presbytery shall have voice.
- 7. All racial/ethnic congregations and other congregations designated by the Administrative Board shall elect an additional ruling elder commissioner.
- 8. Only teaching elders who are active members (including honorably retired teaching elders) or members-at-large of Presbytery, as defined by the *Book of Order*, shall have voice and vote.
- I. The quorum for stated meetings of Presbytery shall be at least fifty commissioners including twenty teaching elders and ruling elders commissioned by at least twenty sessions. The quorum for special meetings shall be half of the above.
- J. Corresponding Members and Visitors. The Presbytery may give voice but not vote to any of the following:
  - Official representatives from the Synod or the General Assembly.
  - Teaching or ruling elders from another Presbytery, a Reformed Church in communion with the Presbyterian Church (USA), or any other Christian church.

Other visitors are welcome to attend as observers, unless the Presbytery, for good reason, votes to go into executive session.

#### IV. PRESBYTERY ADMINISTRATIVE BOARD

- A. Purpose. The Administrative Board shall ensure that the priorities of Presbytery are carried out by the Divisions, committees, and other units, as well as the staff of Presbytery, and that these priorities are reflected in the Presbytery budget. It shall coordinate the many parts of Presbytery to contribute to the life and witness for Christ of the whole Church. It shall foster positive attitudes within the Presbytery and encourage its members to engage in regular prayer regarding the mission of the Presbytery of Western North Carolina, the Synod of Mid-Atlantic, the General Assembly and the whole Presbyterian Church (USA). The Administrative Board is the servant of Presbytery and has only those powers provided by these Standing Rules or authorized by Presbytery.
- B. Membership. The Administrative Board shall be composed as follows:
  - 1. Voting Members
    - Immediate Past Moderator of Presbytery, who shall serve as chair for one year.
    - Moderator of Presbytery, who shall serve as vice-chair for one year.
    - Chair (or his or her designee) from each Division.
    - Moderator of the Presbyterian Women of Presbytery.
    - Six at-large Members, selected by the Nominating and Representation Committees (giving due consideration to geography and experience, with equal number of teaching and ruling elders) and elected by Presbytery,

serving three year staggered terms (two on, two off each year). These may be nominated and elected for an immediate second three year term, after which they may not serve on the board for at least one year before being eligible again.

- 2. Non-Voting Members\*
  - Vice-Moderator (Moderator-elect) of Presbytery, who shall serve as secretary
  - General Presbyter
  - Stated Clerk
  - Treasurer
  - Any staff of Presbytery chosen by the General Presbyter
  - One commissioner to the Synod Assembly selected by the Nominating and Representation Committees
  - One recent commissioner to the General Assembly selected by the Nominating and Representation Committees

(\*At its discretion, the Board may annually grant voting privileges to any of the above)

- C. Leadership Team. The chair, vice-chair, secretary, two at-large members elected from the Board, the General Presbyter and the Stated Clerk shall form a leadership team for the Administrative Board, whose duties shall be to
  - Make preparations for each meeting of the Board
  - Submit recommendations to the Board
  - Carry out assignments given by the Board
  - Take appropriate action on urgent matters that cannot wait for the next Board meeting, such action to be reported at the next meeting
- D. Functions: The Administrative Board shall have the following responsibilities:
  - 1. To lead Presbytery in setting appropriate goals in accord with its Mission Statement.
  - 2. To coordinate the mission and programs of Presbytery.
  - 3. To review the work of all Divisions, committees and other units of Presbytery, offering helpful advice as warranted.
  - 4. To approve the proposed annual budget prepared by the Building Relations Division ensuring that Presbytery's priorities are reflected therein, for submission to Presbytery; and to make adjustments to the budget approved by Presbytery, provided that such are reported to the next meeting of Presbytery.
  - 5. To refer work to, and to hear recommendations from, the Divisions, committees and other units of Presbytery.
  - 6. To approve the proposed docket for the Presbytery meetings prepared by the Moderator and Stated Clerk, in consultation with the General Presbyter.
  - 7. To serve as the Board of Trustees of the Presbytery Corporation, with the right to designate some of their members to exercise that responsibility on behalf of the Administrative Board.
  - 8. To consider requests from congregations regarding the exercise of their property rights under G-4.0206 in the *Book of Order*, and recommend appropriate actions to Presbytery.
  - 9. To recommend persons for the Nominating and Representation Committees of Presbytery, and for the offices of Vice-Moderator (Moderator-elect) and if necessary, Moderator.

- 10. To approve the appointment of persons by the Nominating and Representation Committees to fill vacancies on committees in cases of emergency (subject to ratification by Presbytery).
- 11. To act as a hearing board in matters which may be appealed from the Operations Division.
- 12. To refer actions of the General Assembly and Synod to Divisions and committees for study and interpretation.
- 13. To keep Presbytery informed of its work through reports at each meeting.
- 14. To review Presbytery's fulfillment of its responsibilities listed in the *Book of Order* (G-3.03).
- 15. To authorize celebrations of the Sacrament of the Lord's Supper at retreats, camps, conferences and special gatherings under the jurisdiction of Presbytery.
- 16. To recommend personnel policies to Presbytery for all its employees, which shall embody the inclusiveness required in the *Book of Order*.
- 17. Between meetings of Presbytery, to act on behalf of Presbytery in urgent matters by a two-thirds majority vote, provided that a full report of such action is given to Presbytery at its next meeting.

#### V. DIVISIONS AND COMMITTEES

- A. The Presbytery shall have the following Divisions in accordance with its Mission Statement. These Divisions should include, but are not limited to, the following tasks:
  - 1. **Support** (Equipping Congregation):
    all matters relating to congregational life, teaching elders, pastoral relations, educators, and church transformation, including churches with smaller membership.
  - 2. **Witness** (Sharing God's Love): local and global missions, new church development, and evangelism.
  - 3. **Discipleship** (Making Disciples): spiritual development, education, youth, higher education, and camping.
  - 4. **Leadership** (Developing Leaders): officer training, development of leaders, school for the laity, stewardship, worship, and nominations/representation.
  - 5. **Operations** (Building Relationships): finance, property, personnel, budget, planning, and judicial matters.

#### B. General Regulations:

- 1. Subject to the approval of Presbytery, the Administrative Board shall determine the general responsibilities and the number of members of each Division.
- 2. Working with the Administrative Board, each Division shall determine the committees/sub-committees it deems necessary, as well as the number of members and the duties of each.
- 3. Members of the Divisions and committees shall be selected by the Nominating and Representation Committees and elected by Presbytery. Members of the subcommittees shall be selected by the relevant Division and confirmed by the Administrative Board. Normally, no more than half of these members should be teaching elders.
- 4. Normally, members of the Divisions and committees shall serve a three-year term, may be re-elected, but may not serve more than six consecutive years, after which

- they may not serve on the same body for at least one year before being eligible again.
- 5. All Divisions and committees should report to Presbytery through the Administrative Board to enable it to coordinate activities in Presbytery. The Board may not alter any Division or committee report, but may offer advice to Presbytery concerning Division or committee recommendations.
- 6. Divisions and committees shall develop and implement plans and programs that carry out their goals as adopted by Presbytery, and evaluate and report to Presbytery their activities annually. Many committees may need to meet as a whole only a few times a year, with sub-committees working on specific tasks during the rest of the time. Divisions and committees may also meet by telephone conference, emails, or other suitable methods.
- 7. Divisions and committees shall be encouraged to be creative and to explore new avenues of ministry with accountability to Presbytery through the Administrative Board
- 8. Divisions and committees shall annually submit their budget requests to the Operations Division. They shall carry out their responsibilities within the approved budgets, unless an overrun is approved in advance by the Administrative Board.
- 9. Ordinarily, a person may serve on only one Presbytery Division or committee at the same time. Normally, there should not be more than one representative of any one church on the same Presbytery Division or committee at the same time (except congregations having more than two hundred active members may have more than one representative on the same committee).
- 10. Divisions and committees chairs will contact any committee member after three meetings in a year have been missed (without a reasonable excuse approved by the committee) and inquire as to their ability and willingness to serve at this time, and will advise the committee member that a further unexcused absence will result in removal from the committee. It will be the responsibility of the committee chair to inform the Nominating and Representation Committees when members have missed half of the committee meetings; and the Nominating and Representation Committees shall replace such members as soon as possible.
- 11. Terms of office for Division and committee chairs shall be one year, with no chair serving more than two consecutive terms. Each committee chair shall be nominated specifically for that position by the Nominating and Representation Committees, but still be one of the total membership of the committee. In extenuating circumstances, a third year as chair may be recommended to Presbytery.
- 12. Each committee may co-opt additional members as desired, who shall have voice but no vote in the committee deliberations.
- 13. Divisions and committees are encouraged to suggest to the Nominating and Representation Committees suitable persons for new members and new chairs.
- 14. Each committee may, on its own initiative, create one or more on-going working groups for long-term projects or temporary task forces for specific short-term projects. Both working groups and task forces will report to the creating committee. When a task force has completed its assignment, it shall cease to exist. The membership and a statement of purpose of all working groups or task forces shall be reported to the Administrative Board within a month after their formation.
- 15. Each Division and committee shall keep accurate minutes and copies of all minutes should be submitted to the Stated Clerk.
- 16. The quorum for each Division and committee shall be a majority of its members.
- 17. Sub-committees should comply with all the above regulations and shall report to the

Division and Administrative Board through their committees.

#### VI. PRESBYTERY STAFF

Presbytery shall hire staff as required to fulfill its mission and responsibilities. The General Presbyter shall be head of staff. Staff shall be responsible to Presbytery, reporting through the Administrative Board, and not be responsible to a single Division or committee or sub-committee. All Divisions, committees, and sub-committees shall have support and resourcing. The "Personnel Manual of the Presbytery of Western North Carolina" provides guidelines and policies for hiring, supervising and terminating staff, and for the provision of salary and benefits.

#### VII. AMENDMENT

These Standing Rules for the Presbytery of Western North Carolina shall be periodically reviewed by the Administrative Board, with any changes recommended to Presbytery. Such proposed amendments may be adopted by a two-thirds vote of those present and voting at any stated meeting of the Presbytery.

# COORDINATING COUNCIL ATTACHMENT 2

### Questions and Answers about the Revised Standing Rules of Presbytery

#### 1. Why was a revision necessary?

The new Form of Government in the <u>Book of Order</u> does not provide many rules for administering a Presbytery. So, each Presbytery now has to come up with its own rules.

#### 2. Are there many important changes in these new Standing Rules?

Not really. A great deal of the material in the old rules has been carried over into the new Standing Rules. The membership of Presbytery remains much the same, though the number of Ruling Elder Commissioners has been increased. The most noticeable change is that the Divisions have been given flexibility to determine which committees are actually needed to carry out their responsibilities, which now reflect better Presbytery's Mission Statement. The new committees will be communicated to Presbytery at its January 2012 meeting.

#### 3. Where is the old Coordinating Council?

Since the new Form of Government calls each of the former governing bodies (Session, Presbytery, etc.) a council, a new name had to be devised - Administrative Board, but its responsibilities are largely those of the old Coordinating Council.

#### 4. Is the revision complete?

No. Once the committees are in place, further rules, based on the old Form of Government, must be devised and adopted for some key committees.

#### 5. Can the Presbytery make future changes in these Standing Rules?

*Certainly. The last section describes the amendment procedure.* 

Comment: At its July 2011 meeting, the Presbytery charged the task force to revise the Standing Rules "with the goal of emulating, as near as is practicable and desirable, the simplification of the new Form of Government."

The task force feels that this revision meets the goal of simplification, as well as flexibility, and will better serve our Presbytery in the future.

### MANUAL OF ADMINISTRATIVE OPERATIONS FOR CHURCHES

[NOTE: The Session should review this Model Manual, making any desired choices or changes, before adopting it and recommending it to the Congregation for adoption by a two-thirds vote of the active members, present and voting.]

I. PURPOSE The Presbyterian Church is a member church in the
Presbytery of Western North Carolina of the Presbyterian Church (U.S.A.). It has been called by God and organized by the Presbytery to proclaim the good news of Jesus Christ in worship and service to the needy, and to promote peace and justice in the world.
II. GOVERNANCE  This church's Congregation and Session shall be governed in accordance with the Constitution of the Presbyterian Church (U.S.A.), both its <i>Book of Confessions</i> and its <i>Book of Order</i> . Subordinate to that Constitution, these bylaws and then the latest edition of Roberts Rules of Order (Newly Revised) shall provide specific guidance.
MEETINGS
The Session shall hold stated meetings ["monthly" is recommended]. Special meetings may be called in accord with BO: G-3.0203.
The Congregation shall hold its annual meeting in the church building on the
cover any of the above business items not covered at the annual meeting.
NOTICE OF MEETINGS  Reasonable notice, as determined by the Session [a minimum of 24 hours is recommended], shall be given of all special Session meetings.
Notice of Congregational meetings shall be given at regular services of worship on ["two" is recommended] successive Sunday(s) prior to each meeting, in accord with BO:G-1.0502. The meeting may be convened following the notice given on the second Sunday.

QUORUM FOR MEETINGS
The quorum for Session meetings shall be the moderator and ["a majority" is recommended] of elders in active service on the Session.
The quorum for Congregational meetings shall be the moderator and at least ["ten" is recommended] percent of its active members.
Neither absentee ballots nor voting by proxy shall be permitted in any meetings.
INCORPORATION In accord with the laws of the State of North Carolina, the Congregation shall cause a corporation to be formed (BO: G-4.0101), if such has not already been done. Consistent with the
laws of this state, both ecclesiastical and corporate business may be conducted at the same meeting of the Congregation.
MEMBERSHIP
In accord with BO: G-1.03, the Session shall receive and nurture members of the church. The Session shall create and annually review rolls for all baptized members, active members, and affiliate members in accord with BO: G-1.04 & G-3.0204, also maintaining the required registers.
All members shall carry out the ministries of proclamation, sharing the sacraments, and living in covenant life with God and each other (BO: G-1.0101).
WORSHIP
The Session shall ensure that services of worship of God are regularly and reverently held in accord with BO: Directory for Worship and G-3.0201.
The Sacrament of the Lord's Supper shall be celebrated ["monthly" is recommended] as well as at other appropriate times, as the Session may decide.
The Sacrament of Baptism shall be celebrated in accord with the principles of BO: Directory for Worship.
NOMINATING COMMITTEE
In accord with BO: G-2.0401, the Congregation shall form a nominating committee in the following manner:

#### **DEACONS**

If, in accord with BO:G-2.02, the Congregation determines to have deacons, either individually commissioned or organized as a board, it shall also determine how they are elected, their terms of service, and other matters, analogous to provisions for elders (as near as may be).

#### **RECORDS**

The Session shall ensure that there are proper and adequate minutes, duly approved, and other records in accord with BO: G-3.0107 & 3.0204, and shall submit any requested records to Presbytery in accord with BO: G-3.0108.

#### **COMMITTEES**

The Session, in accord with BO: G-3.0201, shall establish, discharge, and review the actions of any desired committees and other organizations within the Congregation.

#### **AMENDMENTS**

Subject to the Constitution of the Presbyterian Church (U.S.A.), any Articles of Incorporation, and state laws, these bylaws may be amended by a two-thirds vote of the active members of the Congregation, present and voting, provided that the proposed changes have been published at the same time as the call of the meeting at which the changes are voted upon.

My faith journey is my life journey with its profound challenges, hurts, wounds and disappointments, some caused by the choice of another and some self-inflicted which altered the course of my life. There have also been events which have brought extreme happiness, celebrations and blessings.

September 19, 1978 holds tremendous significance in my life since this was the day that our daughter KD was born and I had an epiphany. While observing how perfect she was made I proclaimed, "There must be a God because she is a miracle". I had not thought about the existence of God before but at that moment I became consciously aware of God's love for me through the life of my daughter. This proclamation opened up an immediate blessing, an invitation to attend a "Friendship Bible Coffee". During this bible study, "Examine the Evidence" I professed my love and trust in Jesus Christ as my Lord and Savior. I attended many bible studies over the next 7 years and grew in my love and dependence of God.

Another significant blessing was the Holy Spirit healing me to wholeness from an early childhood event which robbed me of my innocence and a regrettable choice which I made 20 years later. These two life altering events left me with two deep gaping wounds. My personal healing experience has made me acutely aware and empathetic to the pain and brokenness which many people live with.

I have learned the power of prayer! In 1985 we moved from the NW to Greensboro, NC. Before we actually moved I prayed that God would place us in a Christian community with a church that my husband would be comfortable attending. My prayers were answered the second day we arrived when I received two invitations, one to a Christian Women's luncheon the second to visit Community in Christ Presbyterian Church. We joined and I was baptized with our three children in 1986 and later was ordained as an Elder. Reverend Jim Rissmiller and my husband became good friends.

I learned Christian Women's Luncheons were part of Stonecroft Ministries the same organization which sponsored the FB Coffees I had been attending in Portland, OR.

I experienced another blessing when I attended NC Presbyterian Pilgrimage in 1998, where I experienced God in a new, fresh and powerful way. My understanding of God's extravagant love for me became real and tangible. After that weekend my faith life began to grow exponentially and I became more open and obedient to be used by God to express his love and healing powers into the lives of others whom he called me to minister to. I was enabled by my Spiritual Gift to encourage and guide a young homeless man 26 yrs. old to enter a drug and alcohol program and later moved him into a halfway house.

In 2000 I began to pray over two profound disappointments, our marriage of 23 years had become a loveless marriage and our daughter KD was living the college life and I sensed in ways that were harmful to her. I prayer fervently for 6 months that our marriage would be restored because it was simply a legal contract we had yet to form a covenant union with God as the head of our marriage. I prayed that my husband and I would become yoked with God and that he would draw our daughter back into relationship with Him. On a Thursday evening my husband and I decided that we would separate but on Friday evening Russ told me that he had surrendered control of his life to Christ and asked for forgiveness to which I replied, "I will forgive you as freely as the Lord has forgiven me." Truly this was the Holy Spirit intervening to keep our family in tact because on Monday we learned that our daughter was pregnant. Before I spoke with her I prayed for wisdom as to how to handle the conversation and I heard the Spirit say," Don/t judge her, only love her or I will not be able to draw her back to me". I know that what Satan means for harm God will turn into a blessing. These two events were significant faith builders for me. Our grandson Jaeden is 11 years old. KD married a lovely man who adopted our grandson and her relationship with Christ was restored.

I believe my Laity Training and experience as a Crises Pregnancy Counselor, a Facilitator for Sexual, Post Abortion Healing and being a Stephen Minister has prepared me for the ministry of Pastoral Care. My Spiritual gifts of Wisdom, Exhortation and Pastor/ Teacher will also enable me to fulfill my call of employing these gifts to edify The Church. My husband Russ and I have been invited by the Session of Sweetwater Presbyterian church to Co-Pastor, Russ responsible for Administration and I for Pastoral Care and we would share in leading worship and teaching.

#### Biographical Faith Journey for Patricia H. Queen

I cannot tell you exactly when my journey of faith began. I remember going to church with my family at an early age. At about age seven, my dad stopped going to church with us, and soon we all stopped going. At age twelve, when my parents were having financial problems, ladies from a church nearby brought us children sweaters for Christmas. I remember being really touched by their kindness.

When I was in the eighth grade, we moved to Winnsboro, SC. Patsy Oxner, the Director of Christian Education at Sion Presbyterian Church came to visit us. Ms. Oxner showed a great interest in my family and invited us to church. My siblings and I attended Sunday School and church. It was a great social outlet for us. We began going to the Junior and Senior High Meetings. When I was sixteen, my two sisters, brother, and I were baptized and professed our faith in God and Jesus as our Lord and Savior at Sion Presbyterian Church. The only times I remember my parents attending church with us was for our baptism and when we were in the church Christmas pageants or other Sunday morning young peoples' programs. When I was in my junior and senior years of high school, I often played the piano for our opening Sunday School services and helped with the younger children in Sunday school, sometimes teaching. It was during these times that my knowledge of God's Word and young faith grew and matured.

Other than my baptism and profession of faith at Sion Presbyterian, there were two things that left a significant impression on me. The first was when Ms. Oxner asked me to play the part of Mary, the mother of Jesus, in the church Christmas pageant. I have had few things in my life that have made me feel so honored and humbled. The second was when Patsy Oxner left our church to become a missionary in Brazil. The Senior Highs attended her commissioning service at Montreat. I believe her example is what has given me a great passion for missions of God's church.

While a student at Winthrop College in Rock Hill, SC, I attended Oakland Avenue Presbyterian Church and the College Presbyterian Students' Fellowship. In 1969 I married Marvin Hula, moved to Union, SC, taught at the local high school, and joined a Methodist Church there. My husband and I became the Senior High Adult leaders. In 1971, we moved with the Forest Service to Dahlonega, GA, and joined a small Presbyterian church where I served as an assistant musician. It was there that my firstborn, Will, was christened as an infant. From there, we moved to Charles City, VA, to my husband's family's farm. We then joined Providence Forge Presbyterian Church. We attended both Sunday School and worship services regularly; Marvin was ordained a Deacon, and I directed several Bible Schools.

In 1975, my husband was diagnosed with thyroid cancer. My faith strengthened me through the next six weeks of diagnosis and a month spent in New York City for treatment. The 28th verse of Romans chapter 8, sustained me. It does to this day in my times of crisis. Marvin's cancer was gone. We went back to our normal lives. In the fall of 1975, two dear friends and I started Sunshine Nursery School at the Providence Forge Church. That nursery school continues today as part of that church's ministry to the community. During Marvin's episode with thyroid cancer, directing Bible School, and starting the nursery, my faith grew as life, friends, and church family influenced and encouraged me.

In 1976, we adopted our second son, Ted, at age six. In1977, we moved to Williamsburg, VA, and joined Williamsburg Presbyterian Church. We decided we needed a smaller congregation and moved our membership to Jamestown Presbyterian Church in the early 1980's. On February 9, 1985, Marvin, my husband, my children's father, and so much of my strength, fell 25 feet from a grain tank. On February 19, he died without ever regaining consciousness. My world fell apart. Again, I was sustained by faith, Romans 8:28, family, friends, and God Almighty! Soon after Marvin's death, I was ordained an Elder at the Jamestown Church but served for only a few months before we moved.

In 1986 I moved my family to Kings Mountain, NC, to be nearer my own family. There we joined Kings Mountain Presbyterian Church. I was lost. I felt God and His people had abandoned me. I moved us to Charlotte, NC, where the boys and I joined Park Road Presbyterian Church. Again, I felt no connection with God or His people. In 1990, Tom Queen and I began dating regularly. I was just finishing my Masters in Special Education- Supported Employment. I had finally found what I wanted to be when I grew up...an advocate for people with development disabilities and a trainer for the parents and professionals who serve them. During this time of feeling lost, the witness of close friends kept reminding me that God had never left me; He was and is always in the same place waiting for me to reconnect.

Tom and I were married in 1991. He retired and traveled North and South Carolina with me as I pursued my career with Exceptional Children's Assistance Center. In 1993, I worked for the Autism Society of NC and developed their advocacy program. In 1995, my friend and I started our own consulting business, Community Training and Integration, Inc. (CITI). Through CITI, we worked with professionals serving people with developmental disabilities to help them learn more inclusive and respectful ways to serve that population.

During this time, Tom and I visited several churches in Charlotte but never really found a church family with whom we connected. In 2000 we moved to Rutherfordton, NC. We felt really welcomed at Rutherfordton Presbyterian. After Don Scofield became the pastor, we joined RPC in the spring of 2001. Finally There we have been nurtured by Dr. Scofield and the church family. We have attended Bible studies and Sunday School. I have served as Moderator of the Presbyterian Women and as an elder for RPC. I have a passion for missions, serve with the Outreach Committee, and help support a Kenyan couple who are missionaries to their own people.

In 2008 I entered the School of the laity by divine intervention in my life. There my relationship with God deepened significantly. My experience as pulpit supply for several churches over the last eighteen months, including the last four months exclusively at Union Mills has further grown my faith, deepened my commitment to Him, and increased my knowledge of His Word. As I look back over my life, I can see that my experiences and opportunities for service to God and His people have prepared me for the call to serve His people at Union Mills Presbyterian.

#### Biographical Journey of Faith, Thomas .F. Queen, Sr.

I was born in the latter years of the Depression on July 13, 1938 in Charlotte, NC. I cannot remember not going to church in my earlier years, always with my mother and three older sisters. I knew in these early years there was a God, and I believed in Jesus Christ. I accepted Jesus as my Savior, joined the Baptist Church, and was baptized in a creek in western Mecklenburg County when I was twelve years old. Soon afterwards my family moved to High Shoals, NC, where I continued to go to church. When I was fifteen we moved to Honea Path, SC, and I joined Honea Path Baptist Church where I was very active. After high school I attended Erskine College and Clemson College. It was at Clemson that I strayed from my faith and early training.

In 1959, I left college and joined the Army. My spiritual life suffered during my military service years. I was married in 1965 and was blessed with three children. I worked for Pan Am at Cape Canaveral, Florida for ten years. In 1972, I moved to Sharon, South Carolina to a farm to start a new life with my family. At that time I was also working as a salesman for Sears. My marriage failed and I was divorced in 1974. The one good thing from my marriage was my children. I felt the most important thing in my life for the next eighteen years was my children. Although I did not go to church often, my children did. In 1976, I moved back to Florida to get help from my family with raising my children, and to help my mother with my ailing father.

I finished my education at Rollins College in 1976 at Patrick Air Force Base, Florida. I moved back to my farm in South Carolina in 1977, and took my parents with me as they were aging and declining in health. I returned to work for Sears in Rock Hill, SC from 1977 through 1992. My parents died in 1989 and 1990.

In 1990, I met Patricia Hula who had been widowed several years before. She had two sons, both in high school. Pat and I became very close. After about a year we were married. She was an active Presbyterian in search of a new church home. We attended various Presbyterian churches in Charlotte. With the love of my new wife coupled with my past upbringing I began to love God more and more.

In 1992, I retired from my business life. Pat continued to work. We moved several times, first to Sunset Beach, back to Charlotte, and then to Helen, GA. Searching for an appropriate retirement community and wanting to be more centrally located to all six of our children, we moved to Rutherfordton, NC in 2000. We began attending Rutherfordton Presbyterian Church (RPC) in 2000. Through Pat's insistence and God's love for both of us, we found a nurturing church family at Rutherfordton Presbyterian. There I rededicated my life to God and joined RPC. It was here I found a new life, and my faith got stronger.

In 2003, I was ordained an Elder at RPC. I have served as Chairman of the Stewardship Committee, worked on the Outreach Committee for the past ten years, as missions are my passion. I worked at the Soup Kitchen, built ramps, decks, roofs, and been on mission trips to KY and WV numerous times. I help support a Kenyan couple who are missionaries to their own people. They are our brother and sister in Christ, and I have learned much from them.

I believe the organized church is the "Body of Christ" called into existence by God following the death of Jesus Christ for the express purpose of carrying on and carrying out the ministry to which he called his disciples during his life and ministry and to which he commissioned them, to "Go and make disciples of all nations" when he knew the end of his earthly life was near. As Christ walked the earth, preaching to the masses, touching the poor and outcast and healing the sick and lame, so the "arms" and "hands" and "legs" of the church as the "Body of Christ" are called to active, mobile ministry from local communities to global nations seeking to bring justice and healing and spreading the gospel, the "good news" of Jesus Christ, to all the world.

However, as members of the Reform tradition, I believe the life and ministry of Presbyterian faith communities must be thoroughly grounded in, prepared and sustained by: #1) Worshiping and praising God together and interpreting God's will for God's people in the contemporary world based on the authority of Scripture (see above), #2) Sharing in the sacraments of 'baptism" and "The Lord's Supper" as a faith community #3) Informed understanding of the history of our tradition as recorded in our "Book of Confessions" (i.e. *The Nicene Creed, The Apostles' Creed, A Brief Statement of Faith*), #4) and how they can be applied to the world today.

The sacraments of baptism and The Lord's Supper are human representations and re-enactments of something of the mystery of God that we enter into in and participate in by faith and by which we are reminded of the intimate and vital presence of God the Father, God the Son, and God the Holy Spirit in our lives. In baptism, who we are as God's children is demonstrated to us by the cleansing and renewing properties of water and by the fellowship of a faith community vowing personally and corporately to love and teach and nurture the child of God standing before them. In The Lord's Supper, as a church family we re-enact and therein re-member and re-engage, symbolically, with God, the Son, who poured out his life for us that we might live again. And, as we are enriched and renewed as a family of God by these holy sacraments, we are then prepared and fortified to go out into the world and respond to God's calling to us to "Go and do likewise."

#### **Biography**

Rev. Dee D. Liss

I was raised by two atheists. I attended Vacation Bible School the summer after second grade at the Unitarian Church in my hometown of Charlottesville, Virginia. My childhood piano teacher was the organist at a local Presbyterian church and my mentor in college, ---the Baptist -related Denison University in Granville Ohio-- was a Presbyterian minister who chaired the Religion department and served as Dean of the Chapel. Years later, however, it was a Catholic priest who, instead of endorsing the final stages of my "conversion" to Catholicism, said he believed God had other plans for me. "The farthest you could ever go in the Catholic Church, Dee, would be to become a nun," he said and handed me a catalogue to McCormick Theological Seminary in Chicago.

It used to embarrass me that I memorized the Apostles' Creed and the Lord's Prayer while man-handling a U Haul truck down the New Jersey Turnpike hoping and praying to live long enough to actually arrive safely in Richmond in time for "Greek School!" But, ordained as Chaplain and Instructor at Queens College in Charlotte, installed as Associate Pastor at First Presbyterian, Albemarle, trained with the American Association of Pastoral Counselors, and in private practice as a state-licensed pastoral counselor in Charlotte for thirteen years, over the years I found myself relishing the unusual encounters, the profound and often mystical experiences I believe have come into my life as a result of my highly unconventional background and the unique perspective I bring to the ordained ministry. For this, I continue to be truly grateful!

Although thoroughly un-churched for the first part of my life, I grew up in an environment whose emphasis on academia and the arts was as ardent and obsessive as any fanatical, evangelical religion. Looking back on it, unbeknownst to my parents to or me, the "good news" for this early stage of my life was that I believe God had been revealing God's self to me all along--- through the arts: classical music, great literature, paintings by the masters, live Shakespearean theater, opera and ballet. Beginning with my seminary training, for twenty—plus years, it has been my great privilege and joy to be able to go to the Bible, at will, to open it and to learn more about how God is constantly revealing God's self to me and to the world in his Word and in the example of Jesus Christ. Every teaching moment, every prayer, every opportunity for pastoral psychotherapy and for pastoral care, every sermon, every administrative meeting, every tear, every hug, every moment with children in the house of God are all ripe with the grace and the creative possibility that comes in being able to connect some more dots—between God in Christ, Christianity, faithful discipleship, communities of faith, biblical authority, ministry, forgiveness, reconciliation—and today's world.

When I left Queens College, I missed finding God in teaching and in ministry with young adults. When I left the pastorate, I missed the people, the community, the fellowship of the family of God and its power to reach out and touch and heal each other and the world. When I retired from pastoral counseling, I missed the ministry of presence and the sacred ground on which, by grace, the therapeutic process. Stands. But since I have returned to parish ministry, first as pastor to the Glendale Springs Presbyterian Church in Ashe County, NC and now as Interim Pastor to Long Creek Presbyterian Church, everything I'd been missing --- has come back. And I am grateful, once again!

### Margie Boyd Faith Journey

As a child, I alternated between worshipping at my mother's church, First Presbyterian Chattanooga and my father's parish, St. Peter and Paul Catholic Church. When it was time for confirmation, my mother won out and I was confirmed Presbyterian. The next year, though, I entered Notre Dame High School and received 4 years of Catholic instruction. In college, I occasionally worshipped at an Episcopal Church, then a Baptist Church, and even a charismatic fellowship. Such is the journey of faith.

In 1980, while looking for an internship in my graduate program in Recreation Ministries at Florida State University, I noticed a flyer on the wall for a "Club Program Supervisor" at Montreat Conference Center. I drove up to Montreat for the first time, was hired, and subsequently spent the most important summer of my life. I came back to my Presbyterian roots, and discovered that I fit perfectly into the culture and theological framework of the PCUSA. Instead of returning to Florida to work as a recreation director on a cruise ship, I entered PSCE, and after graduating began ministry as a Christian Educator. I expected to work happily as an Educator for the duration of my career, but when my husband was called to Columbia Seminary in 1990, and I became part of the seminary community, I felt the stirring of the Spirit to pursue more learning. After auditing a couple of classes, I knew that my heart was warming towards ordained ministry. So I began seminary immediately after my husband graduated, and my call was confirmed by a wonderful experience at Columbia.

Following graduation, at 40 years old, I became Associate Pastor at Trinity Church in Hendersonville. Following that call, and a 2-year interim Associate Pastor position at Black Mountain Church, I have spent the last 13 ½ years as Associate Pastor at Guilford Park Presbyterian in Greensboro, NC. This community has helped me form my identity, and together we have grown in faith, love, and service. They became a family for me, as I became single again, raised my children, nursed my parents until their deaths, and experienced the ups and downs of life. I will always be grateful to the Guilford Park community for their love and support.

I am turning now to the new opportunities and challenges of serving as a solo pastor/campus minister in the mountains that I love. I so look forward to using my gifts, taking new chances, forming new relationships, and participating in the 'new thing' that God intends to do at Cullowhee Presbyterian Church! I intend to pour my heart and energy into the ministry of this church. As I have been blessed, I hope to bless others, following the example of Christ.

#### Statement of Faith - Rev. J. Whit Malone

When I say, "I believe in God," it is my grateful response to what God reveals. God has graciously chosen to be known in creation; in the words of the Hebrew and Christian scriptures; and most fully in the life, death and resurrection of Jesus the Christ. And though God is free to speak and act in unexpected ways, what I believe finds its primary source in the preaching of Holy Scripture in regular corporate worship, in the sacraments of baptism and Eucharist, in probing the depths of the creeds and confessions of the Church, and in the voice of God's Spirit as it speaks through sisters and brothers in faith.

The Bible is the written Word of God and the primary source of what I believe. Interpreted within the community of faith, using both mind and heart, and illumined by the Holy Spirit, the Bible is the authoritative rule of faith and life, both for me and for the Church. The God revealed in Holy Scripture requires a response. That response is to follow Jesus. And the Bible reveals to us what that means.

I believe in one, holy, and living God who reaches out to us in three persons: Father, Son, and the Holy Spirit. God is essentially relational. Each one of this three is wholly one only in relationship to the other persons. God lives in mutual love and equality and intends this relatedness and mutual love to mark human relationships. This is mystery. God's eternal essence is always greater than our human understanding.

I believe God is creator. In love God creates all the worlds that are and everything God creates is good. God creates human beings in God's image to love God and others. God gives us a vocation to be stewards of all God has made and to live with others in justice and love. God also sets limits, giving us freedom to obey or violate them. We reject God and disobey God's commandments. Yet, God does not reject us; keeping God's covenant promises down to this day.

I believe God is savior. In God's fullness of time and love, God came to us in Jesus of Nazareth. Jesus' involvement in our humanness is God's involvement in our humanness. Jesus was human. He was like us in every way except without sin. And in the living of his life, he revealed what it means to be truly human. Jesus is divine. Being God, he is able to do for us what we cannot do for ourselves – to love us unconditionally, to forgive us, and to restore God's image within us.

I believe God is the living God. God's Holy Spirit is alive and active in our world in ways both seen and unseen. It is the Spirit who makes God real to us in Scripture and preaching and the sacraments. God's Spirit convicts us of our sin, assures us of forgiveness, and calls us to live new lives. And it is through the Spirit that God enables us to respond with trust and obedience and gathers us into the church.

Christ's church does not exist for itself, but for the world. Gathered by the Spirit, in its life together the church is to be a witness to the world of God's intention for human life. Sent by the Spirit, the church proclaims the gospel, strives for justice all relationships, and shows compassion for all people.

In Jesus' life, death, and resurrection, God has overcome the power of hatred, injustice, and death in the world. Yet, the many expressions of sin remain strong. Still, we hope. Even in the face of evidence to the contrary, we trust that God will finish what has begun in Christ.

#### Faith Journey Rev. Whit Malone

I can honestly say that I have never been very far from the church. Growing up in a very active Southern Baptist family, my sisters and I were at church doing something several times each week. When my family sort of drifted away while I was in high school, I found "church" through active participation in Young Life. And though like most folks, I was less active during college, even then I was never very far from the church.

There are really two specific times in which I believe I have heard God calling me to Christian ministry. The first was while I was in middle school. Each Tuesday afternoon, our youth pastor would pile several of us in her car and we would drive from our affluent church down to Atlanta's inner city. There we would meet a bunch of much less fortunate kids who gathered around a Baptist Home Missionary connected to our church. We would swing and play kickball and wrestle around in the grass. We would eat bologna and peanut butter sandwiches. And we would hear a Bible story and have a prayer. It was sometime during one of those many Tuesday afternoons that I sensed I wouldn't be taking over my father's construction company. These early experiences, along with later urban ministry experiences through Young Life, eventually led me to pursue a degree in social work as a way to continue serve those who struggle for the basics of life.

The second experience came during my senior year of seminary. I went to seminary needing to work some things out with God. I was hurting... I was searching... and I was not finding the answers I needed in the faith I had been given as a child. So I studied Bible and theology and had every intention of immediately getting a masters degree in social work and heading back to work in the inner city of Atlanta. But God had another path for me. During my senior year's field work in a wonderful congregation, I experienced a Presbyterian-style call to pastoral ministry. I felt led to the work of preaching and teaching and pastoral care. The congregation affirmed my emerging gifts as a pastor. And that was almost thirty years ago.

Since that time I have been pastor to two small, rural churches in southern Indiana (2 years); an associate pastor for youth and education in a large congregation in Louisville (4 years); and the pastor and head of staff at a suburban congregation also in Louisville (17 years). Currently, I am pastor of Collegiate Presbyterian Church in Ames, IA. (4 ½ years). I feel greatly blessed to now receive the call of First Presbyterian in Hickory to be their next pastor. And I believe deeply that this is at the leading of God's Holy Spirit.

Personally, the loves of my life are my wife, Kris, and my three daughters; Maggie, Emma, and Evelyn. I enjoy cycling, gardening, and building things with my hands.

#### **HUNGER COMMITTEE**

At its May 7 meeting, the Hunger Committee recommended funding the following spring Nickel-a-Meal Grant recipients, and Coordinating Council approved. The checks were presented by Hunger Committee members during worship services at the sponsoring congregation.

- \$2,250 Waldensian Presbyterian Assistance Ministry (Sponsored by Waldensian)
- \$1,000 IFA/Cleveland County Rescue Mission (Sponsored by Shelby)
- \$2,250 Pack-a-Bag Program/Shuford Elementary School (Sponsored by New Vision)

At its July 19 meeting, the Hunger Committee decided to offer Reclaiming Christmas Cards that support Nkhoma Hospital (Malawi), Ebenezer School (Malawi), Children's Scholarships (Guatemala), Theological Fund (Guatemala), and PWNC Seminary Students. These cards will be on sale at the October Presbytery meeting, posted on the Presbytery website, and order forms will be emailed out. In addition, the committee received approval from Council for the Ten Thousand Villages store "A Unique Gift" to sell fair trade <u>food</u> items on Friday afternoon at the October Presbytery meeting, as a way of raising awareness about alternative Christmas giving.

In August, the committee sponsored a workshop at the Let's Celebrate Event entitled, "Seeds and Roots: The Community Garden", co-taught by David Horne and Buzz Durham. And, on October 9, the committee helped support the Jacob's Join Hunger event at Morganton FPC, featuring Bryan McFarland.

#### PEACE & JUSTICE COMMITTEE

This past Spring, the Peace & Justice Committee allocated twelve Peacemaking Offering Grants to churches using funds from the 2010 Peacemaking Offering. The grants were for program/projects that encouraged peacemaking. This worked so well that the committee decided at its June 22 meeting to repeat the process this coming year. So, the Presbytery's portion of the 2011 Peacemaking Offering will be used to fund small grants of at least \$250 to churches that are working in concrete ways toward peacemaking in the community or the world. The grant form is in the attachment of this packet, but paper copies will be available in the display room at the October Presbytery meeting and will also be emailed in November. The deadline for requests is December 31, 2011, and the form simply asks for contact information, a paragraph description of the request, and that recipients provide a picture and update by September 2012.

Also at its June meeting, the committee requested (and then received) approval from Coordinating Council to sell Zatoun Fair Trade Olive Oil from Palestine on the Friday afternoon of the October Presbytery meeting, to raise awareness of alternative Christmas giving. The Committee also approved \$500 to help support the PCUSA National Multi-Cultural Conference taking place in Charlotte April 26-29, 2012. The conference is being sponsored by the presbyteries in NC and the Synod of the Mid-Atlantic.

In conjunction with the Guatemala Partnership, the committee hosted PCUSA International Peacemakers Karla Koll and Juana Herlinda Yac Salanic (Guatemala) the week of September 23-29. They spoke at the Presbytery's Presbyterian Women's Fall Gathering at Waldensian, Waldensian Presbyterian Church, Iglesia Emanuel, Gastonia FPC, Warren Wilson Presbyterian Church, Black Mountain Presbyterian Church, and Asheville FPC.

#### MISSION COMMITTEE

The Mission Committee budget helped scholarship three people to attend the August 11-14 Malawi Mission Network gathering in Austin, Texas: Dorothy McKenzie (who led a workshop) and Steve and Jane Hansel (Swannanoa FPC). Grace Boyer (staff and steering committee member) also attended. Speakers included Mission Co-workers Frank Dimmock and Jim McGill, PCUSA staff Debbie Braaksma and Gail Bingham, The Deputy Moderator of Blantyre Synod, Rev. Mercy Chilapula, and presenters from University of Livingstonia, Marion Medical Missions, Africa Bags, Medical Benevolence Foundation and other agencies. Classes on a wide variety of topics were offered, such as new medical trends, culture, and Chichewa language. The next gathering will be August 23-26, 2012 in Colorado. Dear Presbytery of Western NC Mission Committee,

Going through a list of supporters, I am reminded of your constant prayer, concern, visiting/encouragement and very meaningful gifts that have time and again enabled us, in tough corners, to continue our work. The new surgical ward and burn center have just opened and were filled to overflowing by the next day. We had nearly 9,000 admissions to the pediatric ward alone last year, and a 2% mortality rate as opposed to the Malawi government target of 7%. Outreach clinics are extending the reach of the health system to many that have struggled to have any services at all, and we are working on a school based healthcare program that we hope will help keep kids well enough to learn in school. Your help has contributed to all of this, and we are deeply grateful.

Dear Friends,

Greetings from New Jersey, where we are finishing up a family visit with entertainment from Hurricane Irene, which has delayed our departure back to Malawi. We now depart on Sept  $1^{st}$  and wanted to give you an update about Nkhoma prior to departing.

We continue to be extremely busy at Nkhoma Hospital, having cared for over 17,000 inpatients and 45,000 outpatients at the hospital in the past year, and over 4,000 inpatients and 84,000 outpatients at our health centers during that same period. 8,500 new mothers had access to lifesaving prenatal care, and thanks to better delivery and newborn care techniques, many more babies left the hospital alive and well. Almost 60,000 people had homes sprayed for malaria mosquitos thanks to a grant by PCUSA, resulting in a 75% drop in malaria in communities tested and a 10% increase in hemoglobin among children in those same areas, a vital factor for kids doing well at school. What do these numbers mean in more human terms? A mother who has lost eight previous children has left the hospital with a healthy newborn. Kids that have had strokes and severe brain damage or death have siblings that have escaped severe malaria, and communities are very grateful for the help they have received. Many that have severe malaria have left the hospital well as a result of a critical care program that has provided training and equipment to our wards and stocked a new pediatric emergency room. Many

malnourished children have received food aid, enabling us to better assess their home needs and make diagnoses of hard to prove illnesses, like tuberculosis. An eleven year old boy who had been unconscious on the pediatric ward for over two weeks returns robust and the picture of good health after two months on TB therapy. New ties with the Malawi College of Medicine enable us to offer diagnosis and some treatment for children with severe heart disease. The HIV/AIDS department has continued to improve its capabilities, enabling diagnosis of young children with HIV in time to start life saving anti-HIV medicines, as well as keeping parents alive and well to care for their families.

We face daily challenges, as Malawi enters a time of even more severe financial constraint and many of our patients' admissions supposedly funded by Malawi government, have to be carried by overseas donations. Foreign exchange, needed for buying medicines and purchasing fuel to run ambulances, has become very scarce. With the continued electrical outages we are experiencing, there is risk of patients on oxygen or needing emergency surgery dying as a result of no fuel to run backup generators, and our small generator has proven too limited to run all areas of the expanding hospital. Malawi has become politically troubled as well, with many donor nations withdrawing aid over human rights issues, and mass demonstrations planned. These severe disruptions could lead to despair over the ability of Nkhoma Hospital to remain open and serve patients. We continue to lift our needs up to the Lord, who has sustained us through numerous disasters over the past years, and ask you also pray for us. ### General Presbyter's Report October 21 & 22, 2011

When we gather to worship, learn, and fellowship at this two-day Presbytery meeting, I hope it will be a time of renewal and encouragement in the faith. We are coming together with brothers and sisters who are committed to following Jesus Christ and to serving him in our churches. Using the image from scripture, "We are branches abiding in the Vine - in Christ's love - and we are to be bearers of much fruit."

All of us are challenged these days to find new ways to reach those who do not know Christ and/or do not have a church community that is encouraging them to grow in their faith. We are also challenged to grow in our own personal faith and to help those in our churches do the same. Then we are "sent" by Christ to share God's love with a broken and hurting world. This is a big job. My prayer is that our focus will be on following and serving as a body of Christ.

The Presbytery Council, at the request of the Evangelism Division, has declared that in 2012, our focus will be *Evangelism*. Because of my concern for people who do not know the love of Christ, I am excited about next year's focus; reaching out to people for Christ, inviting them into a relationship with Christ, and helping them grow in faith. You will see this in Presbytery meetings and other events throughout the year. I want us to be encouraged to reach out to those who do not have a church home or a relationship with Jesus Christ. My hope is that next summer, many of our churches will read and preach through the book of <u>Acts</u>, and that the Spirit will put us on fire for the gospel! At the two-day October Presbytery meeting in 2012 (October 26 & 27), Ray Jones, Coordinator for Evangelism at General Assembly, will be our speaker. This emphasis will help us learn how to better express our faith, and how God's love is important to us in our lives. *God's love is truly good news!* 

I am often asked what a Presbytery does. At this meeting, you will receive a booklet that will try to summarize some of the things we do together. It is really a "thank-you" booklet for the work that you are doing. While thinking about the difference Presbytery has made in some situations, I read a letter that Dr. Barbara Nagy had written to describe for Morganton First the differences she observed from our work in Nkhoma Hospital. This is in addition to our Presbytery's help in starting a preschool that now extends to 3<sup>rd</sup> grade! Please continue to keep Barbara and Malawi in your prayers. I have attached her letter because I think it is essential for you to realize what an important part you in this Presbytery have contributed to the hospital. It is an example of what we can do working together. (GP Attachment 1)

When I look around the Presbytery, I see so many places where God is at work. Revivals are abounding. Laura Long shared how the Lord worked through a revival at Clinchfield in Marion, where Hazel Dula preached. Bill Lowe is preaching at Duncan's Creek's revival and Love's Chapel just finished a revival. There are a number of groups around the Presbytery where pastors are getting together for Bible study and prayer. Some of these are lectionary groups and others were started with Acts Initiative, but include other pastors. These can be a great way for prayer, fellowship and support. If you would like to be in a group, contact the Presbytery office.

Margie Boyd's first Sunday at Cullowhee was September 25. She is excited about working with the Campus Ministry and the church. Margie would like to know names of students attending Western Carolina University from your church so she can include them in the campus ministry activities.

Whit Malone will be coming to First Hickory in October as their new Head of Staff. He and his family are looking forward to getting back down south!

The Bryson City Church began a new ministry in partnership with other churches in Bryson City for the purpose of doing home repair projects in Swain County. The church hosted a group from Sharon Presbyterian Church in Charlotte on September15-18 to work in partnership with them. They look forward to hosting other groups next summer.

The Let's Celebrate Event in Morganton was attended by 235 people. Many people said they felt the workshops were some of the best they had ever attended. They included workshops on small church, evangelism and music in the church. There was also a track for youth and special activities for children planned by Ann Aichinger.

While I am excited about the ministry and mission we are doing together, I know there are also people within our denomination and this Presbytery that are focused on whether they should stay in the PCUSA, or go to another Reformed body or Presbytery. There are also people trying to come up with ways to do both. I believe that our denomination and Presbytery need the voices of each and every church. I believe Christ has called us together. While there is a group looking at leaving, there is also a group committed to the PCUSA which is looking at reformation within the denomination. It is my hope that while some struggle with options, we will still be in conversation together and will do things that build-up the body of Christ.

I believe that all of us are beginning to understand that the mission field that used to be overseas is now in our back yard. <u>We</u> need to do things differently! We need to become a more welcoming people and also a people that reaches out beyond our church family and take risks for the gospel. I have seen the evidence of your fruit, and we can't stop now! God is at work in our midst. Thanks be to God!

### ATTACHMENT GP 1

For the Stewardship Campaign, First Presbyterian Church Morganton

19 September, 2011

I am walking down the Pediatrics ward in my mind this evening, thinking about how the day has gone, and, as usual, asking how we could have managed the numerous crises and challenges better. There are several newborns that were so asphyxiated at delivery that they were unable to breastfeed, always a bad sign. This usually occurs when deliveries at home or remote health centers have not gone well. They have started to feed now, and it looks like all are going to make it. We have had our usual outbreak of meningitis at this time of the year, but better medicines have enabled numerous children to live without significant brain injury: a three year old breaks into a big smile as she finally understands her azungu doctor telling her she gets to go home instead of getting another injection. We have an eight year old boy in a corner bed with newly diagnosed diabetic ketoacidosis, a disease with a much higher mortality in Malawi than HIV, but he is doing better after using up about five bottles of precious glucose test strips. We considered sending him to our referral hospital in Lilongwe due to the amounts of insulin and lab reagents we had to use to treat him, but the referral hospital ran out of insulin and other meds several months ago. We have lots of kids with severe pneumonia slowly improving with oxygen and antibiotics, a difficult combination to maintain since the electricity is off almost every day, the hospital runs on a back up diesel requiring generator, and the whole country is out of diesel again, a regular occurrence. We are just sending home a bright little 11 year old that had a rhabdomyosarcoma, a cancer of the muscle, removed at one of our sister mission hospitals. Incredibly she has no sign of the cancer a year after surgery, but the medicines she received to fight it seriously weakened her heart, and she needed treatment for that. A team of visiting surgeons is busy in the outpatient department seeing patients for specialty surgery that may not be available in Malawi, at least not at subsidized mission hospital prices, or in a place that people from our area could ever hope to get to. They and a group of visiting specialists in HIV care are also teaching our staff and improving our ability to care for all sorts of problems. I spent an hour in a conference about keeping relief food available for outpatients and ended up hearing that plans to extend our mobile outreach clinics to about 5,000 more pregnant women and children per month are coming to fruition, a project we have been working on for several years.

I have been asked how your giving has impacted the people in our hospital's area of care. When I first came to Malawi we had no oxygen in the hospital. Gifts from people from Western NC have changed that so that a child dying from pneumonia at Nkhoma Hospital is now rare. After the oxygen was made available we had further deaths every time the electricity went off because oxygen concentrators require electricity, but visiting mission teams helped us with a generator and an emergency activation switch, again saving numerous lives. We had frequent pediatric deaths because the hospital ran out of blood on a daily basis. One of our mission teams concentrated on improving the lab, which can now provide emergency blood for transfusion in sometimes as little as 15 minutes, which has saved many critically ill malaria patients. On three occasions, emergency infusions of cash have kept Nkhoma Hospital open, when funds owed by Malawi government failed to be paid and the hospital had utilized every available means to purchase medicines. You have nurtured and financially supported one of the few pediatricians in the entire country, enabling over 9,000 pediatric inpatients in the last year to have access to specialty care, helping health care facilities all over the central part of the country learn how to take care of newborns, and teaching, teaching all cadres of medical practitioners how to care for sick kids. Space does not permit to tell about houses built for much needed staff, remodeling of health centers to make them livable and functioning, the establishment of a high quality school in the Nkhoma community and much else. What I will say is that many have asked about Africa, 'Why can't they finally improve?' A big part of the answer is that people face so many obstacles on a daily basis they have lost hope that things can ever change. Your walking together with the people of Malawi in prayer, presence and financial support has begun to change the way people think about their community and themselves. Ordinary people are beginning to see that working together they can improve their communities; they see a future and a hope for themselves and their families. These types of changes are not cheap, they are not quick, and they are not easy. Thanks for hanging in there with us as we pray and hope for God's Kingdom to come in Malawi and also at First Presbyterian Church in Morganton.
