The Presbytery of Western North Carolina will hold its quarterly stated meeting on Tuesday, July 31, 2012 at the Black Mountain Home for Children, Youth and Families in Black Mountain, North Carolina. (80 Lake Eden Road, Black Mountain, NC)

Registration will begin at 8:30 a.m. and continue until 11:00 a.m. Please sign in at the registration area upon arrival. (Registration will be in the lobby of gym.)

Lunch tickets will be available for a cost of **\$8.00** per person during registration. (Lunch will be at the First Presbyterian, Gastonia, Picnic Pavilion; catered by Okie Dokies Smokehouse of Swannanoa.)

Intercessory Prayer requests should be placed on the Clerk's table by 11:00 a.m.

Driving Directions:

Watch for signs indicating designated parking. All ministers and commissioners are strongly encouraged to mutually work out car pooling arrangements. Churches are asked to collaborate on using one van for all who could meet at a convenient location.

Black Mountain Home for Children is located in Black Mountain, just 10 minutes west of Asheville, North Carolina. To reach the Home:

From the West:

I-40 East to Exit 59 (Swannanoa); Left at the Stop Sign onto Patton Cove Road; .4 miles to red light; Right at the red light onto U.S. 70; .3 miles to the first red light at Whitson Avenue; Left onto Whitson Avenue, then an immediate right onto Old U.S. 70; 1.8 miles to Lake Eden Road; Left on Lake Eden Road, proceed up the hill .3 miles. The entrance to the Home is on the right at the top of the hill in the bend of the road directly opposite Charles D. Owen High School.

From the East:

I-40 to Exit 59 (Swannanoa); Right at stop sign onto Patton Cove Road; .4 miles to red light; Right at the red light onto U.S. 70; .3 miles to the first red light at Whitson Avenue; Left onto Whitson Avenue, then an immediate right onto Old U.S. 70; 1.8 miles to Lake Eden Road; Left on Lake Eden Road, proceed up the hill .3 miles. The entrance to the Home is on the right at the top of the hill in the bend of the road directly opposite Charles D. Owen High School.
